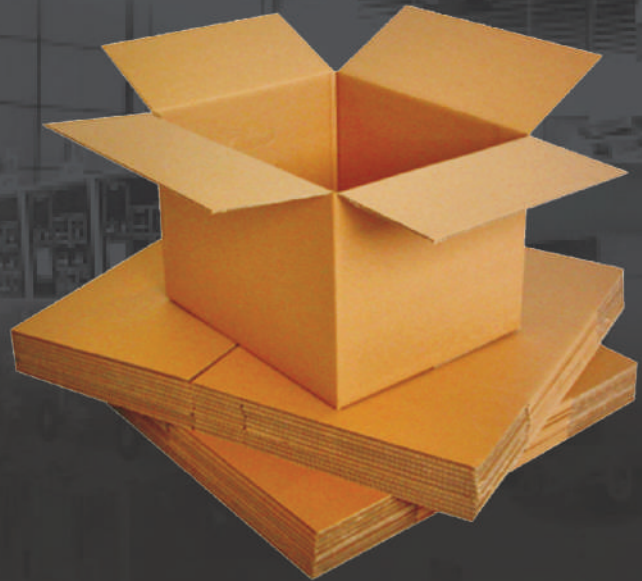

## Modern Methods of Increasing Employee Productivity

Having improved engagement within the organization will also be another advantage of employee productivity. When there are more productive, they engage and are more willing to participate and be involved with the business activities within the organization. The National Chamber of Exporters (NCE) conducted its 28<sup>th</sup> Annual General Meeting on the 14<sup>th</sup> of March 2023 at the hotel Galadari main ballroom. The official AGM was followed by the Post Business Forum and networking session, attended by over 200 Participants comprising Members, Service providers, Chamber Partners, and other special invitees.

The National Chamber of Exporters of Sri Lanka (NCE) became the only trade Chamber in Sri Lanka serving exclusively the Export Sector. The Membership of the Chamber is open to all exporters of products & services and suppliers of products and services to the export industry.

NCE Past Presidents

The Membership of the Chamber represents leading exporters of all product and service sectors in Sri Lanka. They range from different scales, Large to Small export-oriented enterprises. The Chamber's services are primarily focused on its Members to promote and sustain international market share and be global brand leaders. Due to this commitment and working towards archiving goals of the Membership the Chamber is nationally identified as the 'VOICE OF THE EXPORTER'.

The official AGM commences at 6 PM when the new council, Management committee was appointed. The Chamber also nominated its Patrons who are past presidents of the Chamber.

The outgoing president Ravi Jayawardane in his address emphasized the importance of resurrecting the Export Development Council (EDC). The EDC should become the house for all export trade economic plans as well as structure strategies for product development, market development, and many more segments in the export field. Most importantly the EDC should Lead the concerns of the exporters to be discussed with the relevant representatives. The EDC could be the common platform to discuss and resolve the issues faced by the exporter community in Sri Lanka to facilitate exporters to overcome constraints arising from policy and operational issues created by various institutes that regulate, operate,

and facilitate cross-border trade. "we got a lot of problems to solve". Said, Ravi.

In his speech of Mr. Jayewardena, he requested the authorities to pay more attention to the export sector where they should build a smoother and a productive system to upgrade the services to the exporters in the country.

Mr. Jayantha Karunaratne, the newly elected President of the NCE highlighted the service offered by the Chamber for the benefit of their member as well as the Exporters of the Country. He has been associated with the NCE for almost 20 years and services on the management committee and as a Vice president for the past 4 years.

Speaking on the internal barriers faced by the Sri Lankan Exporters Mr. Jayantha stated that the Chamber will be regularly meeting with relevant stakeholders to discuss and work on a solution as the Exporters are the highest foreign currency earners to the countries and they need to be motivated and encouraged and importantly removing the red tapes and barriers faced by them.

Sri Lanka's export earnings in 2022 hit a record high of USD 13 billion. Earnings from exports in 2022 surpassed USD 13 billion per year for the first time, recording an increase of 4.9% from the previous highest recorded in 2021, This year Exporters are expected to reach 18.5 Bil



USD ( for products and series) and I am sure that the Sri Lankan Exporters will rise to the challenges and meet the targets stated Jayantha ..

He further stated that the USD was at LKR 203 at the beginning of last year but it went up to LKR 365 by end of the year. To some extent, depreciated Rupee helped us to increase our sales and to achieve such high targets. However, now we have seen US Dollar coming down to about LKR 315 which is about 13% appreciation over 2 weeks.

Though the appreciation of the Rupee will help to reduce the cost of imports and help reduce consumer prices, the input prices such as commodity prices, interest, electricity, and other overheads should come down drastically for exporters to meet competition. It is to be seen how such a drastic appreciation of the Rupee could help the export industry.

He further stated that he intends to work closely with the members to find ways and means on how we could become more competitive in the international market.

“I wish to promote Innovation and Value addition and encourage our members to engage in R&D to upgrade their products and services by understanding the NEW NEEDS. I intend to work closely with regulatory authorities and create awareness among our members of the updates, regulatory changes, and standards that are needed for our exporters to make them stronger to face the competition, stated Jayantha.

We will also be lobbying strongly with authorities and leaders of our country to introduce long-term policies related to Trade. We have seen in the past that successive governments keep changing policies and plans which makes our business plans unproductive. So we urge the regulators to have a clear long-term

consistent plan for industries and exports so that we, the private sector can work, plan and venture into business which will bring productivity, enhance exports and expand our economy stated Jayantha

Mr. Murtaza Jafferjee (Chair – of Advocate Institute) who was the Guest of Honour and Keynote speaker highlighted important areas in Exports of Sri Lanka and also provided insight into Sri Lankan Exports in comparison to other countries in the region. Talking about the Export performance in Sri Lanka, Mr. Jafferjee stated, “Compared to countries like Vietnam and Thailand, Sri Lankan exports have contributed very little to GDP growth. Highlighting the importance of increasing the product basket

and becoming a part of a value chain. He also emphasized the importance of Trade Agreements stating that Trade agreements will provide a lot more opportunities for Sri Lankan exporters to reach new markets and have competitive price advantages. He also highlighted the BRANIN drain that has taken place and the recent increase in where Sri Lankan professionals with expertise are moving

out of the country. He also said, “retaining talent is going to be your biggest challenge a lot of creative talent who work as freelancers are available on the internet”. Concerning the present financial crisis Mr. Jafferjee stated there are three reasons why this current financial crisis happened. Namely; misallocation of resources, reduction in taxes, and failure of institutions.

As a special feature of the event, the NCE strengthened its Certificate of Ethical Trading process by partnering with INDEXPO. The CET is a certification that is introduced exclusively to NCE members who fulfill 8 principles related to Ethical Training. Ethical trade is about having confidence that the products and services in the market have not been made at the expense of workers in global supply chains enjoying their rights.

These principles are internationally recognized and identified based on the results of researches and trade delegations. CET is Exclusively for NCE Members. Non-members cannot apply for the certification. There is a special award in the NCE Annual Exports awards “NCE Challenge trophy for the best ethically trading exporter”. The INDEXPO was represented by their President Mr. Canisius Fernando, Mr. Shantha Kuruppumullage - Director/ CEO, and also Mr. Aruna Amardasa - Assistant General Manager.

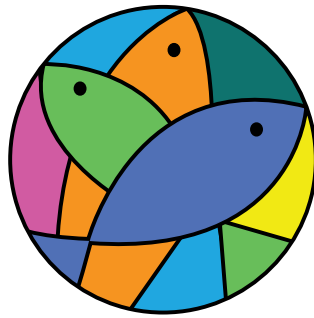

# PCQI Training

The NCE conducted the latest online course on Preventative Controls Qualified Individual (PCQI), from 22<sup>nd</sup> to 24<sup>th</sup> February 2023, under partnership with Hatton National Bank PLC(HNB).

The participants who completed the 03-day course will be certified as US Food and Drug Administration (FDA) qualified individuals. This will facilitate their respective organizations to export to the US food and beverage market effectively.

On successful completion of this FDA-approved standardized curriculum,

participants received a Food Safety Preventive Controls Alliance (FSPCA) PCQI certificate recognized by the FDA and issued by the Association of Food and Drug Officials (AFDO) and the International Food Protection Training Institute.

Fulfilling the requirements to be a PCQI is a critical step in exporting food and beverages to the United States. This programme was conducted by Kemasorooby Vasenth, a certified instructor in Preventive Controls for Human Food.

This course is aimed at exporters seeking to meet the training requirements for the PCQI.



## A Webinar on the German Act on Corporate Due Diligence on Supply Chains

# Spotlighting opportunities in Africa



**“Africa has her mysteries, and even a wise man cannot understand them. But a wise man respects them”** says Miriam Makeba. Considered the second largest and the most populated continent in the world, the fast-growing population and markets in this country present important opportunities for business. Being the second largest continent of the world Africa has unlocked gates to many growing businesses. According to a report by the ‘Brookings’ website, it is said that there are more than 400 companies that earn annual revenues of 1\$ billion or more. They are also fast-growing and lucrative compared to their global peers.

Africa can be considered a continent of about 54 independent countries which are rich in a blend of native people, cultures, economics, and history. This is also considered by many scientists to be the origin of mankind. This is home to vast deserts and tropical rainforests. Arabic is the most widely spoken language there are around 2000 various languages spoken in Africa and each of those languages has a different dialect.

The fast-growing population and markets in Africa give important opportunities for business. On the other hand, great innovation and investment from businesses are vital to achieving the country’s unfulfilled demand for certain goods and services. This closes the gaps in its infrastructure, creates jobs and helps to get rid of scarceness.

According to the research done it is mentioned that the population of Africa is growing fast and it is projected to reach 1.7 Billion by 2030. This growth will occur in cities, moving as the fastest urbanizing region in the whole world. While this incensement happens there will be rises in income all over the continent which will generate new business opportunities in the consumer sector market. According to the report by Brookings, the annual spending by African consumers and businesses will reach up to \$6.66 trillion by 2030, and will outgrow the market in various sectors where they have unmet needs, including foods, beverages, medicines, financial services, healthcare, and education.

Another profitable opportunity for the investors is; Africa pushing to close its infrastructure gap. The poor infrastructure

is one of the crucial weaknesses to investment and growth in Africa. However, even with this lagging infrastructure, Africa has made significant progress. For instance, the annual investment in infrastructure has doubled to about \$80 billion in one year since the start of this century. This shows how it represents a great opportunity for investors and certain upcoming entrepreneurs in helping to solve Africa’s infrastructure challenges.

Being home to some of the world fastest- growing economies the demand for consumer and capital goods are always high in their local markets. For this purpose, most African economies are said to depend on imports to please the needs and requirements of their large populace.

Considering the facts that are mentioned in the ‘African business pages’ exporting to Africa looks much more lucrative than in the past. Already countries like India, US, Brazil, and China have increased their business dealings with the African continent. Among the reasons to export to Africa, it is seen that they host the majority of the top ten fastest-growing countries in the world. Even the IMF estimates that economic growth in the areas like sub-Saharan will be overcome in 225 with a percentage of 6.5. 2025 will be another year in Africa where close to 65% of their labor force is expected to have some kind of secondary-level education. Another important fact according to the African Business Pages is that the world bank believes if the current growth rates continue, most African countries will reach ‘middle income’ (US\$1,000 per person a year) by 2025. As there are around 125 million families where income exceeds \$5000 they can spend more than half of their income on flexible spending. The great news is that they expect this amount to cross 150 million by the year 2025.

There is a variety of products that the African content imports. If any organization is looking to break into the African market, there are many means to try out as an exporter. When it comes to the topic of pharmaceutical products, Africa has a big demand for items such as medical drugs, vitamins as well as health supplements. As there are Africans who suffer from a variety of health conditions mostly in the

rural areas which have underprivileged entrée to drugs adds more bulk to this demand.

Exports of raw materials such as iron and steel which are mostly needed in the African market are indeed another profitable business. That is because Africa cannot produce those metals due to the lack of funds and the high demand in their urban areas.

Automobile spare parts and cars come with a lot of new regulations and charge with the high usage of vehicles and demand for cars in that continent. Spare tires, batteries, lubricants, and different other mechanical pieces which are needed for repairs are also in high demand in Africa. Therefore, many countries have been exporting a wide variety of automobile parts making a neat profit with those export sales.

Even if other countries try to move away from plastic, the demand for plastic raw materials is in great demand. The reason lies in the results of the urbanization process that took place in the past decades. With the people increasing living in the cities, the need for objects at low prices came in need. Mostly in countries like Nigeria half of their population lives in the urban areas. Because of these reasons, the need for plastic materials and objects became a real struggle.

With the rise of population and urbanization textiles and different clothing, demand increased. Textile items of clothing can be considered one of the main exports to Africa. However, the best thing to do when exporting clothes to Africa is to export to the urban areas. The rural and still developing areas will not have good sales of the exported clothes.

When it comes to food and beverages, rice is being imported to Africa in high quantities in recent years. As countries like Nigeria are huge fans of rice there is never enough on the market. This great demand for rice is a good opportunity for foreign exporters. Even if African countries start to harvest rice, it will not be sufficient to cover the high demand. In the present state, most Africans consume rice imported from countries such as India, China, Thailand, Pakistan, and Malaysia.

Given these details, there are enormous opportunities in Africa to export goods. The only thing to keep in mind is to have a sound knowledge of the market. The business that produces machinery and equipment, chemicals, petroleum products, scientific instruments, or foodstuffs has a great opportunity in hand. After all these, it is important to have an agent who can travel to the specific target market and establish a network of customers in Africa. This will allow

the organization to concentrate on supply and production. According to the data in the 'African Business Pages' some countries such as Nigeria offer both free-of-charge and fee-based market research tools to help possible exporters from various countries to analyze the market and gain insight into specific sectors.

Sri Lanka's interactions with Africa are as old as the country's history. There are records of African visitors that were frequent in Sri Lanka in the early times. It is similarly said that the descendants of these early settlers still live in Sri Lanka in communities in areas such as Sirabiadiya, Trincomalee, Batticaloa, and Negombo. Talking about the ties with Africa, since independence Sri Lanka has held together diplomatic ties with Africa through several multilateral fora. As a result, today Sri Lanka has strong diplomatic ties with 45 African States. Additionally, Sri Lanka has 10 Honorary Consuls in the African region.

Economically, Sri Lankan engagement with Africa can be considered at a budding stage currently. There is significant potential to increase trade, investments, and people-to-people ties in a beneficial means for Sri Lanka. Sri Lanka's trade with the African region has grown steadily over recent years, though it remains a small part of the country's total trade.

A fact to consider is, despite efforts to improve Sri Lanka's economic relationships with Africa, there are said to be many cavities. These include the lack of quality infrastructure, limited knowledge of markets among Sri Lankan businesses, and high trade costs. There is the main strength of Sri Lanka to improve export quantity is its strong diplomatic presence in the region covers 45 of 54 countries.

In terms of opportunities, Africa is one of the world's fastest-growing countries as mentioned in the previous sections. However, there are still limitations and hazards that could arise concerning the barriers to trade between Sri Lanka and Africa. Limited connectivity is a noticeable challenge. Despite sharing an ocean with Africa, there is still a sizeable distance between Sri Lanka and the region. Additionally, Sri Lanka does not have any FTAs (Free Trade Agreements) with African countries which may become a reason in some cases for limited encouragement to engage in trade with these countries. Thus, in the hope of ensuring strong diplomatic ties and favorable conditions for growing economic relations, Sri Lanka may consider focusing programs with African economies. All in all, it will be a great chance for Sri Lankan exporters to increase ties with major regional organizations such as East African Community, and Southern African Development Community through FTAs. With these regional groupings, it will open easy access to gain a grander market.

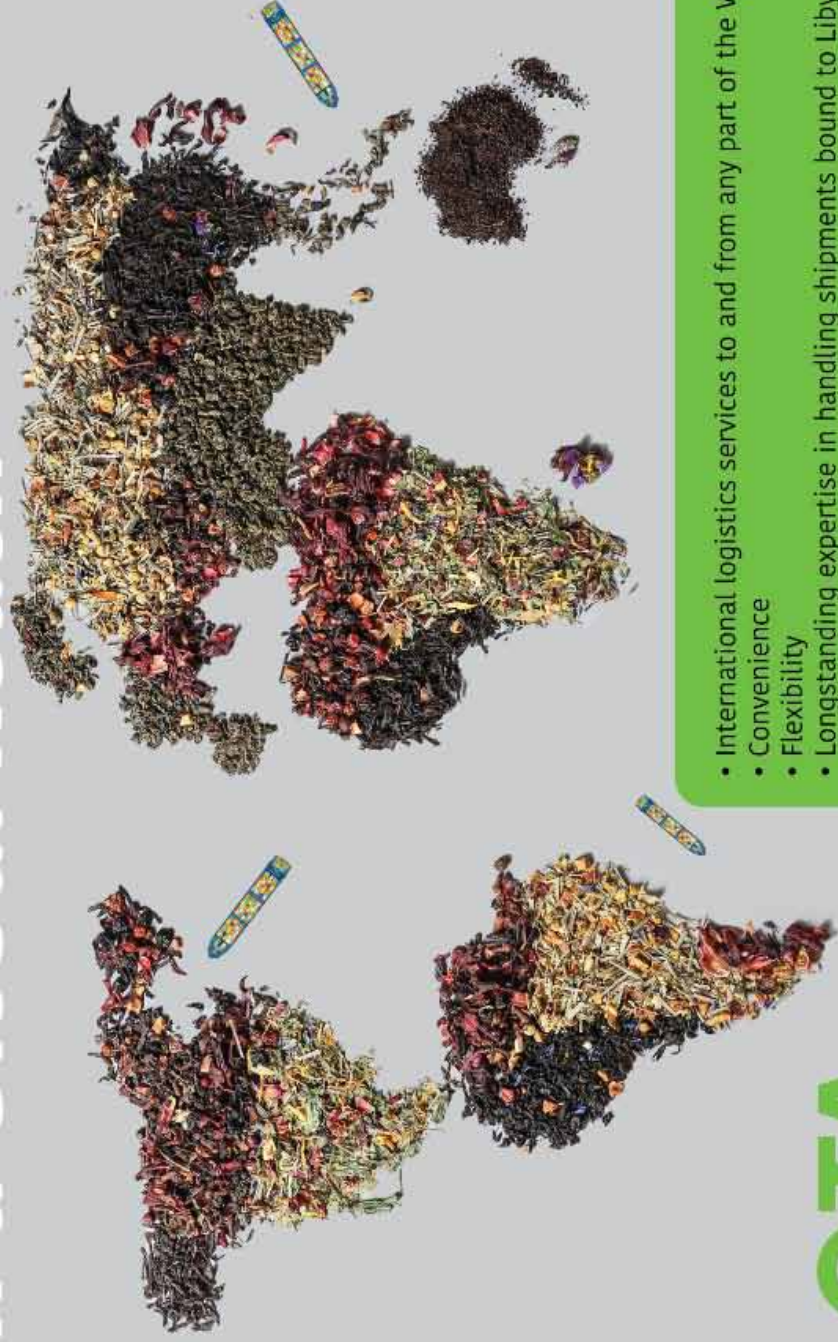

# The importance of the Ethically Trading

The rise of the conscious consumer has been accelerated by the unprecedented events of the COVID—19 pandemic. Thus, quality, safety, and equality are becoming more important for consumers and retailers who look forward to satisfying the demands of their customers. Due to these reasons now has become the best time for companies to adopt Ethical trading.

Ethical trade is a wild-growing field both in terms of interests and practice. Thus, companies can use codes such as the Ethical trading initiative base code for guidance on what to include. The U. Ks Ethical trading initiative is an alliance of organizations that works together to promote and support ethical codes of labor throughout the supply chain. The Ethical Trading Initiative promotes by giving voice to the local workers, transparent business practices, and government intervention to protect workers' rights. When it comes to Ethical trade, it can be regarded as a term that is now commonly used by numerous businesses broadly speaking. It has also come to refer to the working conditions and rights of those in global supply chains.

According to the Ethical Trading Initiative, they say that 'Ethical trade is about creating confidence that your products and services aren't made at the expense of workers' rights. More and more companies now recognize that ethical trade is simply essential business practice'.

Ethical trade not only creates enormous benefits for people around the world, but it also represents an opportunity for brands. The reason for this is that ethical trade changes the entire buying cycle. There is a rise in conscious consumers. Unlike the old customer, the new customer profile is different because they are more aware of issues like the quality and safety of products, where they have come from, who have made them, and how workers have been treated during production. Thus buying behavior I changing and the relationship between global business organizations and the customer who support them transforms by the rise of this conscious consumer. According to a report statement by Deloitte, they state that. "the COVID-19 pandemic has not changed only the served consumers to think about their buying habits. With the shift out of the pandemic, brands that sift t businesses model reflects a more equitable and conscientious approach to trade will likely benefit from consumer loyalty"

Another very important reason to shift to ethical business is that it will soon become a legal requirement to do. Considering countries like Australia. In the US to the EU regulations are being developed to tackle e modern slavery, child labor, protection of human rights, and fair wages. Hence, becoming an ethical business at present reduces the likelihood of falling out of the law in the near future.

Similarly, financial performance data has clearly shown that

investors prefer ethical businesses and they want to invest more in such organizations. The best example is that the Global Sustainable Investment Review reveals an increase of 15% in sustainable and responsible investments (SRI) in the last two years. Ethical trading always gives a good Commercial opportunity.

Considering the Ethical Trading Initiative there are some positive impacts that grab the attention. Among those, one of the largest impacts is an improvement in working conditions. These conditions include training on emergency drills, improved fire safety chemical use and etc. changes in the health and safety sector also empower the workers to feel safe and cared for at work. Thus the quality of their work will be more.

When the working hours are reasonable, the workers with families get the chance to enjoy the extra free time with them and the workers who want to work more than the usual hours get the chance to enjoy some extra money for overtime. Other than these, avoiding child labor will move the business towards an ethical trading business.

Considering the workers' and managers' relations is another important fact in an ethical trade process. Open and clear communication between the companies, managers, and employees is the basic ethical working condition. This establishment helps to increase communication productivity and allows everyone to open their voices.

On the other hand, physical and social well-being is another sector that improves with the principles of ethical trade. Studies have shown that "physical and social benefits are being felt by all workers and have effects not just in the workplace but also at home". Following these, as the workers are less vulnerable to social problems resulting from income instability and health problems ultimately get the chance to escape poverty.

Promoting environmental sustainability and protecting animal rights is also a part of the Ethical trading process. And there

are merits in an integrated approach to managing social and environmental impacts.

Certain steps can be taken to become an environmentally friendly organization such as; the intention to reduce and prevent pollution wherever possible. Take measures to reduce waste in all areas of the business. For example, material waste is recycled where possible; fit toilets with water-reducing flushing systems; fitting low voltage lighting where practical and keeping power usage at a minimum during and outside working hours; usage of waste paper for note taking and confidential documents and shreds for mail order packaging; off-cuts in the material produced in the manufacturing process and re-used to produce other items.

Investor and buyers' protection is important. Ethical and trade practices are vital for a developing country like Sri Lanka. Sri Lanka participates in the export sector in a very vital manner. Thus Ethical Trading is as vital as the business. This ethical trading has brought Sri Lanka into a global trading hub. According to the Sri Lanka Export Development Board, ethical and sustainable manufacturing has been deep-rooted in Sri Lankan industries since ancient times. The country is still in the process of developing a universal investor and buyer protection framework in addition to the bilateral investment promotion and protection treaties.

In modern international trade, it is becoming very significant for exporters to conform to Fair & Ethical Trading Practices, protect of environment and adhere to sustainable development to maintain a competitive advantage in the market.

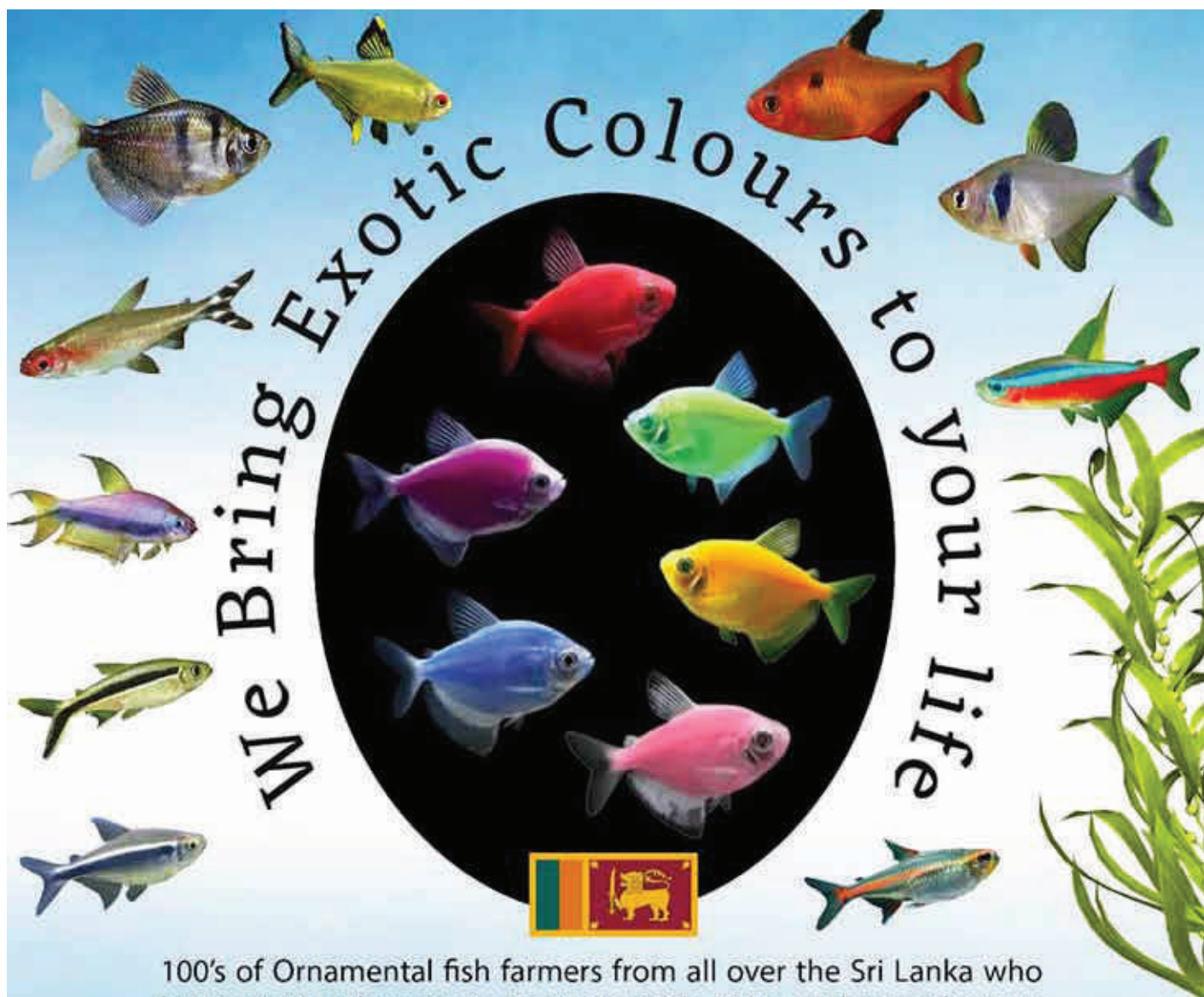
