**CONDITIONS OF MEMBERSHIP**

- **Eligibility for Chamber membership:** Any legal or natural person born in Sri Lanka or incorporated bodies can apply, subject to Council approval and adherence to specified criteria.
- **Council authority:** Elected Council has ultimate authority to approve memberships, set guidelines, admission criteria, and fees, with decisions being final.
- **Membership fees:** Council may set enrollment fees, annual subscriptions, and other payments, subject to approval at General Meetings.
- **Non-payment consequences:** Failure to pay annual subscriptions results in loss of voting rights and other privileges; Council may also revoke membership.
- **Withdrawal process:** Members can withdraw by giving one month's notice to the Secretary-General and settling dues for the entire year. Please note the Membership fee will not be refundable.
- **Membership cancellation:** Council can cancel membership with a 2/3 majority vote if a member breaches terms, no longer meets criteria, or harms Chamber reputation; no refunds are provided.
- **Verification process:** Chamber may request additional information from members to ensure compliance with criteria post-membership.

Any person, group of persons born in Sri Lanka, or incorporated bodies (should be legal and natural persons) shall be eligible to become members of the Chamber subject to the approval of the Council, under the appropriate eligibility Criteria.

Who has been in the business for a <u>minimum of one year</u> where total exports amount to a <u>minimum of 10% of the total annual turnover</u> , with a <u>value of a total turnover of USD 10,000.00 and above.</u>	Indirect Exporters – Those who have been in business for a <u>minimum of two years</u> and supply a <u>minimum of 25% of products or services of their turnover to direct exporters.</u>
51% of voting rights are held by citizens of Sri Lanka.	Service Providers to Exporters - Any Institution (incorporated in Sri Lanka under any Law or Statute) which is performing a role relevant to and/or connected with exports, trade, industries or commerce in Sri Lanka.
