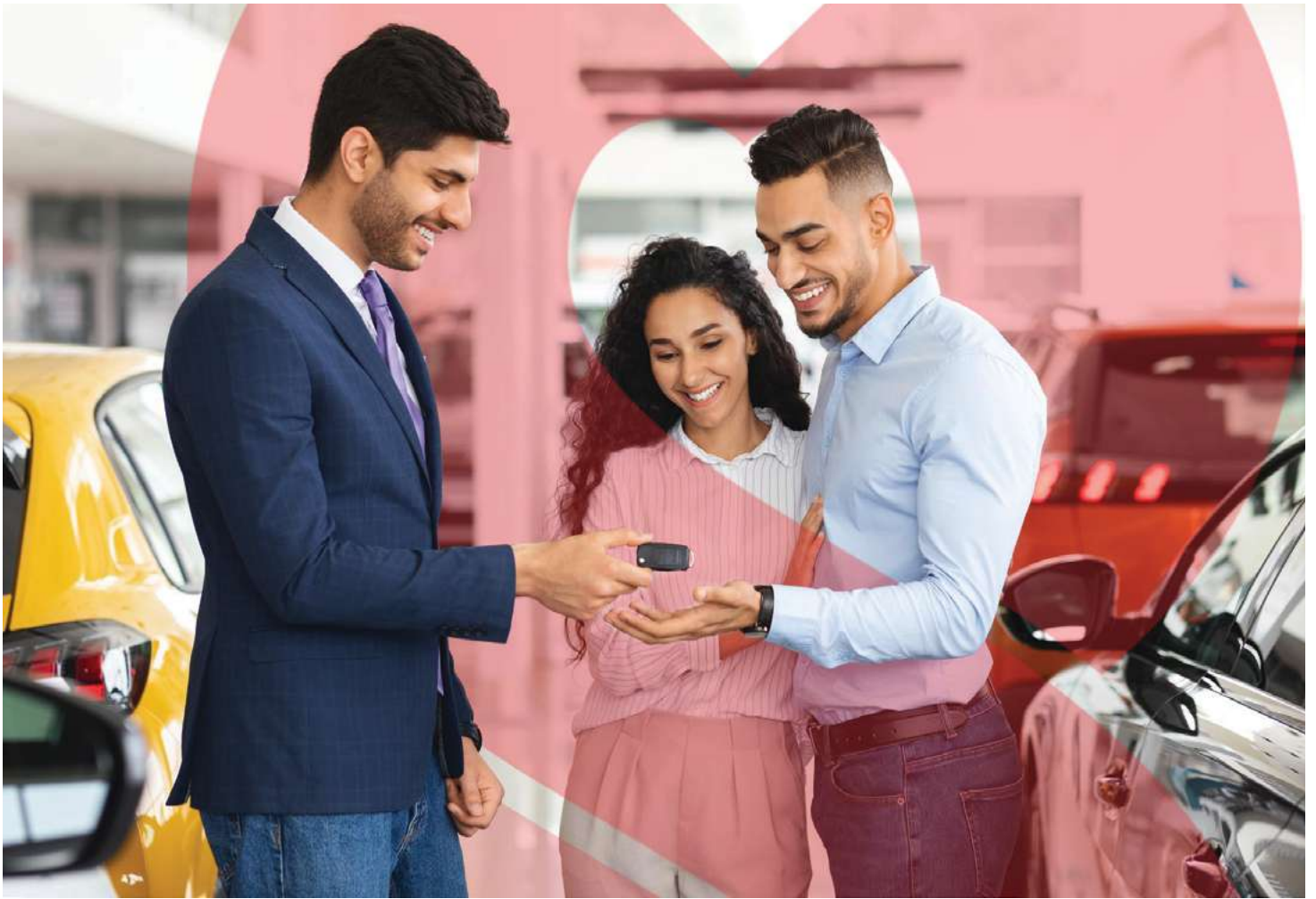

The black color of the trophy conveys 'Authority and Power' in terms of color psychology which is reminiscent of the real nature of exports.

NCE Export Awards 2024 Honours Sri Lanka's Top Exporters



The National Chamber of Exporters of Sri Lanka (NCE) hosted the much-anticipated **32nd Annual Export Awards** on December 6, 2024, at the grand Shangri-La Hotel in Colombo. Marking over three decades of uninterrupted tradition, the event once again shone as the pinnacle of recognition for Sri Lanka's export industry, celebrating the extraordinary contributions of exporters who have elevated the nation's presence on the global stage.

This year's gala, themed "**Embrace Innovation and Digitalization,**" brought together a stellar gathering of over 750 attendees, including top business leaders, exporters, and representatives from the public and private sectors. With its focus on honouring excellence, the event served as a testament to the resilience, ingenuity, and dedication of Sri Lankan exporters amidst an ever-evolving global trade environment.

The NCE organized the awards program as a cornerstone of Sri Lanka's business calendar. This year, the awards featured a significant **structural change**—a streamlined system designed to enhance exclusivity and global recognition for recipients. Under the revised format, only one **Gold, Silver, and Bronze** award were presented in each category. This change, part of the Chamber's strategy to elevate the benchmark for excellence, was widely lauded for enhancing the prestige of the accolades. Additionally, **Merit Awards** were presented to recognize exporters who demonstrated commendable performance but did not secure one of the top three awards in their respective categories.

The 2024 edition included **105 Sectoral Awards** and **10 Special Awards**, celebrating achievements in areas such as Value Addition, Branding, Innovation, Research and Development, and Emerging Markets. Winners were evaluated based on a **comprehensive framework** that extended beyond revenue to encompass criteria like sustainability, ethical business practices, and global market impact.

The President also commended exporters for their resilience in navigating challenging economic conditions, stressing that their achievements have kept Sri Lanka’s trade ambitions alive and thriving.

In modern international trade, it has become vital for exporters to conform to changing regulatory needs and consumer preferences through good practices related to trade, labour, ethical behaviour, the environment, and society to have a competitive advantage in international markets. In line with offering high-quality services to all its members, the National Chamber of Exporters of Sri Lanka (NCE) has commenced a special service for the issue of a 'Certificate of Ethical Trading' (CET) to member exporters who follow ethical trading practices and conformity to good environmental and social practices, based on the eight principles that have been developed by the Chamber. The Certificate of Ethical Trading (CET) is exclusively for NCE member exporters. The technical evaluation conduct by the Indexpo Certification Limited.

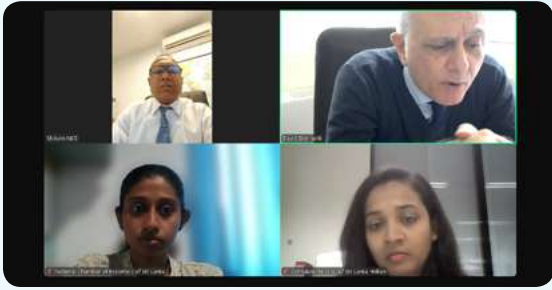
Trade Delegations and Market Access Activities



NCE Signs MOU with the South African Chamber of Commerce and Industry (SACCI) - (October 2024)

December 2024 – Online Meeting

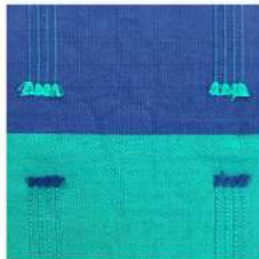



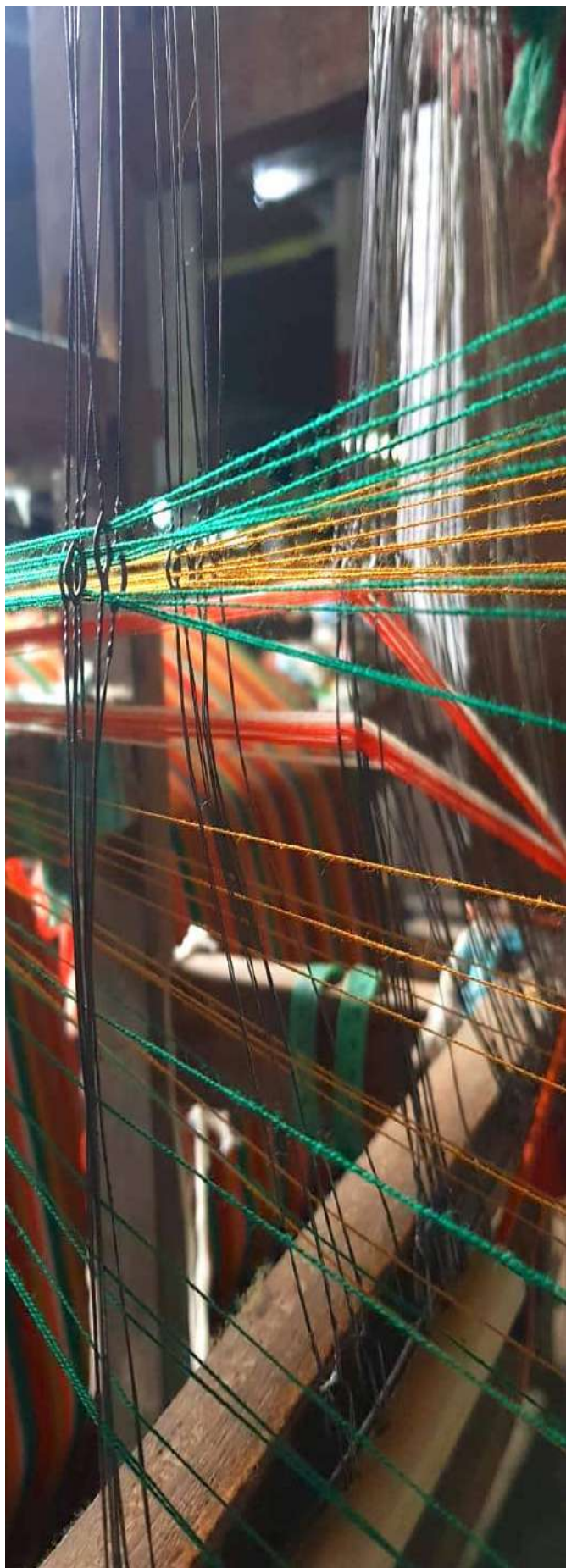

KANDYGS HANDLOOMS

The art of handloom weaving is an art form that predates 2500 years in Sri Lanka. Textiles, a necessity that has been taken for granted, holds a rich history of how humans and machinery have evolved over the years. Handloom weaving is one of the most traditional forms of creating beautiful fabrics, it is completely sustainable having a minimum impact on the environment. Yarns are interlaced together to create yards of cloth. A woman sits at a machine, dictating the design, the density and what the cloth will become. The handloom holds a special place in the textile industry, one of its unique strengths lies in its versatility, which enables it to produce complex fabrics. Another key advantage is that it does not require electricity for fabric construction. Furthermore, the handloom industry has the ability to operate very successfully as a rural industry empowering the weaver, mainly women.

Since 1971, Kandygs has been passionately following the traditional art of handloom weaving, by creating the best quality fabric, and has become a well-established company manufacturing, retailing and exporting finished textiles to the global and local market. Over the years, the landscape of the handloom industry has shifted and there are a few Sri Lankan manufacturers that still work in an ethical manner to keep the art of handloom weaving alive. Kandygs is one of the pioneers of the handloom industry in Sri Lanka and has been leading this effort.

Kandygs was started by Felix and Sita Yahampath, it was started with just 10 machines in their back garden. The Kandygs name is derived from the first initial of the names of their children. Presently, the company is operating as a family business, with the second generation joining the business in the 1990s and as of 2015, the third generation followed in their footsteps. Over the years, the company has evolved into housing over 300 handlooms, 30 power looms, 50 sewing machines and a fully equipped dye house. Our first store in Colombo, Sri Lanka opened its doors in 1976, expanding to 3 more outlets. We entered the export market in 1980, beginning in Europe with countries like Norway, Finland, Germany, the UK, Spain and then expanding to Japan, the Maldives and South Korea.

The handloom market in Sri Lanka is varied based on which company you purchase from, as it is dictated by the quality of weaving, yarn and dyeing. The Kandygs consumers are conscious of quality and design as it is a high-end specialized market. We promote the concept of slow, ethical and sustainable textiles that protect the traditional industry. When you purchase a product from Kandygs you safeguard this tradition and essentially bring tradition home. We have the added advantage of complete customisation and product development. We accommodate and encourage design innovation as long as it does not compromise our ethics. Our aim is to weave contemporary designs of the highest quality whilst safeguarding and nurturing the traditional handloom industry.

SUSTAINABLE, ETHICAL PRODUCTS

All our products are handmade in Sri Lanka. Our fabrics and products are developed and designed by Kandygs. As weavers of fabrics, our product range is wide and varied. We only use natural raw materials that are kind to nature. We weave with cotton, bamboo and jute yarn. Bamboo is an ecological alternative to the exhausted cotton industry. Our weaving with bamboo project has resulted in export innovation awards. Our products are built under the concept of slow fashion especially being home textiles, with the correct care, can last over many years.

Coloured yarns are woven by hand at our factories in Maharagama and Padukka or at our cottage weaving villages located across the island. Our pure cotton fabrics are excellent for curtaining, upholstery fabric, cushion covers, kitchenware, table cloths, serviettes, place mats, rugs, wall hangings, bags and clothes. We also have a soft line of cotton fabrics which is excellent for clothing and accessories. We weave handloom soft fabrics out of pure bamboo yarn. This is ideal for clothing, sarees, shawls, throws and toys. Our in-house sewing unit is utilised to the maximum by our design team to develop and customise products out of the fabrics we weave. We want to push ourselves and our customers towards sustainable, ethical products that our kind to people and nature.

For over 40 years we have been exporting worldwide. Primarily Europe and Asia (Japan, South Korea & The Maldives). Our European buyers have been primarily department stores and retailers that were sourcing home textiles such as readymade curtains, cushion covers and table linen. We started exporting to Norway and Finland in 1980 and have since then moved on to countries in Western Europe such as Germany, the Netherlands, UK, Spain and Italy. In the early 90s, we also entered the export market in Asia with countries such as Japan and South Korea.



We specialise in interior décor, since we are able to provide a coordinated unit of curtains, cushion covers, bed spreads, table linen and decorative wall paneling. This resulted in our expansion into the hotel and resort industry in Sri Lanka and the Maldives. Our experienced technical and design team are able to work closely with architects and interior designers to innovate and develop designs specific to their requirement. Over the past 20 years, we have continued to work with over a 100 hotels and resorts in the Maldives and a countless number in Sri Lanka, who have trusted us to deliver a good quality product in a timely manner.

SAMPATH BANK'S STRATEGIC FOCUS ON EXPORT FINANCING DRIVES SIGNIFICANT GROWTH AMID SRI LANKA'S EXPORT CHALLENGES

Sri Lanka's export sector has seen significant growth despite facing numerous challenges. Exporters play a crucial role in driving foreign currency inflows into the country. As part of its strategic efforts, Sampath Bank PLC has emerged as a key player in supporting exporters with tailored export financing solutions.

In an exclusive conversation with Exporter magazine, Ms. Muditha Liyanapathirana, Senior Manager – Export Financing of Sampath Bank, discussed the bank's role in promoting the country's export growth.

According to Ms. Liyanapathirana, Sri Lanka's export figures have increased by almost 12% this year, which indicates the sector's resilience. However, Sampath Bank has achieved a growth well above industry levels in dollar terms over the same period, underlining the bank's strong commitment to the export sector.

"We have worked diligently to support our customers and boost export volumes, achieving a significant growth compared to last year. But we believe there is still a gap that needs to be bridged. With combined efforts of financial institutions, government institutions, and exporters, we can close this gap and further strengthen Sri Lanka's export position," she explained.

Exporters are essential contributors to Sri Lanka's foreign exchange reserves, and growing this sector remains vital for the nation's economic stability. Ms. Liyanapathirana highlighted the need for more export activities, stating that despite recent growth, the country could benefit from new initiatives, especially with evolving government policies and political stability.

Strategies for Export Growth and Customer-centric Approaches

Sampath Bank's success in the export sector did not happen overnight. A few years ago, the bank revamped its export division, focusing on enhancing customer relationships and introducing competitive financing options. This unpredictability often leads to financial losses if the currency value drops after an exporter has locked in a quotation with a buyer.

"There's a need for greater stability in the financial environment, not just for exporters but for all stakeholders," Ms. Liyanapathirana pointed out. "Many of our clients prefer stable rates, as this gives them confidence in managing costs and margins."

Additionally, rising logistics costs have burdened exporters. Given the competitive nature of global markets, Sri Lankan exporters cannot easily pass these rising costs onto customers, which has squeezed their profit margins.

Government and Financial Support

In response to these challenges, Sampath Bank has worked hard to ease the burden on exporters by offering competitive financing options. The bank has shown flexibility by drastically reducing interest rates for exporters, offering attractive terms that mitigate currency risks.

Future Opportunities for Exporters

As Sri Lanka recovers from economic difficulties, Sampath Bank remains committed to empowering exporters. According to Ms. Liyanapathirana, the bank sees further growth potential in the export sector, especially if political and economic conditions remain stable. She emphasised the need for collective action, with banks, the government, and exporters working together to ensure a conducive environment for growth.

While the bank is doing its part by offering competitive rates and building strong relationships with its clients, Ms. Liyanapathirana stressed that exporters also need to receive additional concessions and support from the government. This is particularly critical, given that exporters in other countries, such as Bangladesh, Kenya and UAE, often benefit from significant tax incentives and other advantages that make them more competitive on the global stage.

"We have seen some exporters move their operations to countries like Bangladesh, Kenya and UAE because of more favourable regulations and tax holidays. To keep Sri Lanka competitive, we need to create a similarly supportive environment," she concluded.

Sampath Bank's dedication to Sri Lanka's export sector is clear. Through its customer-centric approach and tailored financing solutions, the bank is paving the way for sustained export growth, even in the face of challenges. As the country's economic landscape continues to evolve, Sampath Bank is well-positioned to support exporters in seizing new opportunities and driving long-term success for the nation.

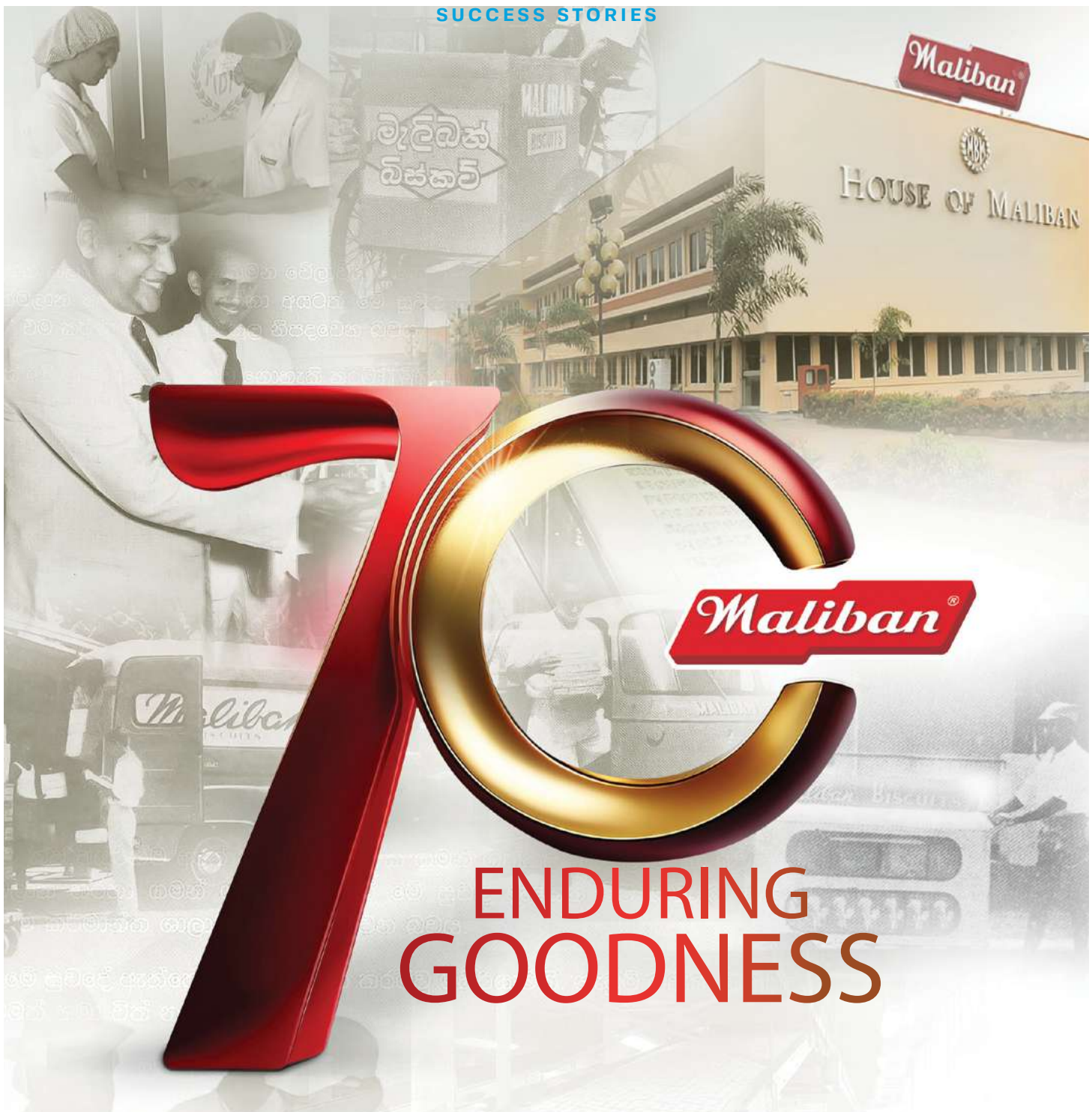

EXPANSION OF EXPORT PORTFOLIO INTO THE LUCRATIVE CHINESE MARKET

1. Economic Outlook of China

China's economic growth has reached 5% year-on-year with its GDP reaching US\$ 18.77 trillion in 2024. Value added industries have shown steady growth continuously. Innovative development continues to be strengthened, with R&D funding. The Global Innovation Index 2024 released by the World Intellectual Property Organization ranks China 11th among the world's most innovative economies. During the past year, China has made significant progress achieving record highs in grain output, new energy vehicle production, railway trips, and foreign trade volume, among other key indicators.

China's foreign trade has remarkably progressed over five decades since its opening in 1981. In 1981, its total trade amounted to only US\$ 2.5billion. China's total external trade of goods in 2024 amounted to US\$ 6.00 trillion, registering exports at US\$ 3.5 trillion and imports at US\$ 2.55 trillion. Three primary trading partners are the ASEAN, the EU and the USA. As the

Sri Lanka is looking forward to exploring new trade and investment opportunities. China is the second-largest economy in the world, and it is a very thriving, innovative, technologically advanced economy. This article will present trade between Sri Lanka and China including economic outlook of China, bilateral trade, market access developments and opportunities and challenges.

world's second-largest importer and a major trading partner of more than 150 countries and regions, China has hosted the China International Import Expo (CIIE) for past 7 years, inviting businesses from around the globe to explore the vast potential of its 1.4 billion consumer market.

2. Bilateral Trade

Sri Lanka being an economic partner of the Belt and Road Initiative (BRI) enjoys close economic ties with China. The total bilateral trade between the two countries reached US \$ 3,347 Mn

for 2023. Sri Lanka has exported with a value of US\$ 257.73Mn to China in 2023 and increased by 2.5% compared to 2022. The main export products are Ceylon tea, apparel, natural rubber-based products, gem and jewellery, mineral, activated carbon, coconut value added products, confectionery products and fisheries products. Apparel, Ceylon black tea and coconut value added products are the main products exported with a value of US\$ 65.5 Mn, US\$ 55 Mn and US\$ 43.44 Mn respectively in 2023.

Sri Lanka has increased imports from China from US\$ 160 Mn to US\$ 4.0 billion during the period 1995-2021. It has been observed that until 2008, the imports were stable but with the increase of rapid development of telecommunication, electrical and electronic sectors, imports from China have remarkably increased widening the balance of trade. Imports have decreased from 2021-2023 due to tight control of the outflow of foreign exchange with many import restrictions. In 2024 up to October, imports from China to Sri Lanka amounted to US\$ 3,509 Mn in the sectors such as electronics, telecommunication equipment, fabric, yarn, plastics and metal.

3. Progress of Market Access for New Products

The General Administration of Customs of China (GACC) is the regulatory body for importation of food and related agricultural products into China. There are several Laws, Regulations and Decrees applicable for importation of food and agricultural products into the Chinese market. Under the Registration Regulation, export establishments are required to be registered with the GACC with effect from January 1st of 2022. The following steps must be followed by exporting country for selected agricultural/fisheries/meat products to be eligible market access into China.

1. Application and acceptance
2. Questionnaire and risk analysis
3. On-site examination
4. Confirmation of entry inspection & quarantine requirements

Following proactive communications and collaborative efforts with the competent authorities during the past two years, Sri Lanka has been able to gain market access to five products sectors by signing market access Protocols on sanitary, phytosanitary and quarantine between the two countries. Accordingly, marine aquatic fisheries, fresh pineapple, Ceylon cinnamon, poultry (Chicken feet), wheat bran pellets have successfully gained market access. Marine aquatic fisheries, fresh pineapple, Ceylon cinnamon export enterprises which are registered and recommended by the competent authorities of Sri Lanka have already completed the registration process with the GACC.

4. Untapped Opportunities & Challenges

China's trade in goods with the Belt & Road Initiative (BRI)

partner countries has reached US\$ 3.07 trillion in 2024 which has accounted for 54% of China's imports. There is a great potential for Sri Lanka to become an important trading partner of China under the BRI. Chinese market is a lucrative market with 1.4 billion population and an active player of global supply chains. To capture the Chinese market for Sri Lankan products, supply capacity, adhering to quality and food safety, innovations, brand development, packaging and digitalization are important factors to be considered. New product opportunities can only be secured if considerable efforts are made to increase the supply capacity, adhering to global standards and registration requirements. A few examples are:

a) High -value Marine Fisheries Products: Ceylon Crabs, Shrimps, Lobsters etc.

There are 30 companies registered with the GACC, but export performance is not substantial due to many reasons. Inadequate supply is the key to meeting the demand. China imports crabs from India, Indonesia and the daily trading volume is around 250MTs. Sri Lanka exports as small volumes of mixed types and unable to meet required volumes.

b) Fresh Pineapple: Gaining market access is not a simple procedure which takes at least 2-3 years to complete the process. Currently, four companies have registered with the GACC for fresh pineapple. There is a need to improve the supply capacity to make a significant impact on the export basket. Sri Lanka further has a capacity to expand for tropical fruits such as mangoes, mangosteen, durian, tropical banana if a steady high quality supply base can be established.

c) Cocopeat:

Chinese market has a ready demand for cocopeat. The registration regulation has also been changed since August, last year and new registration of companies needs to be adhered to the documentary evaluation of process of the production, processing and fumigation requirements.

d) Ornamental Fisheries: There is a potential, but registration of exporting enterprises has not been completed yet.

Sri Lanka is not a bulk producer but a niche producer of products with distinctive quality. Recently, the Embassy organized a media briefing on Sri Lanka's national brands and potential products. Twenty-one media releases were published on on-line media highlighting unique selling points

of Ceylon tea, Ceylon cinnamon, fresh pineapple, Ceylon crabs and Ceylon sapphires. The message was well captured by the Chinese consumers and industrial users.

To capture the untapped opportunities in the Chinese market, the most important point that needs to be highlighted is that it requires an integrated approach with the competent authorities which formulate regulations, policies and monitoring system for exporting enterprises as promising exportable industries. For example, for the aquatic marine fish and inland fisheries supply sustainability, establishment of enterprises monitoring system and registration regulation are vested with the Ministry of Fisheries (Department of Fisheries and Aquatic Resources/NAQDA) and for Poultry (meat Products), and ornamental fisheries, registration of exporting enterprises & monitoring responsibility is under the purview of the Department of Animal Production and Health (DAPH).

The National Plant Quarantine Services and Animal Quarantine Services have a great role to play in this process. These are the institutions which issue quarantine certifications and recommend export enterprises with internal registration system, ensuring Sri Lankan enterprises comply with the sanitary, phytosanitary and food safety requirements for food and non-food agricultural exports and implementation of the signed protocols between Chinese Customs and Sri Lanka. In this context, special attention should be paid to capacity building, enhancing the level of competency and strengthening these units with adequate staff.

Further, digitalization of procedures, innovative packaging and marketing strategies are important when entering the Chinese market. Social media and e-commerce are two popular strategies of digital marketing in China. These marketing strategies have created a platform for consumers to discover, evaluate, and purchase desired products. Increasing purchasing power of tech savvy consumer segment has become an integral part of the day-to-day online shopping among Chinese consumers. Popular e-commerce and social media platforms such as Taobao (monthly traffic 275.6mn), Douyin (traffic 231.6Mn), Pinduoduo (traffic-354 Mn), Xiaohongshu (traffic 151.5 Mn), JD (traffic 133.4 Mn), Tmall (traffic 81.1Mn), Alibaba/1688.com (traffic 41.5Mn), SmZDM (traffic 29.8), Meituan (traffic 9.5Mn), Dianping (traffic 7.8Mn) are the active players in the consumer market. Sri Lankan companies should consider such opportunities in liaison with Chinese partners for introducing ready-to-use consumer products. The companies which have positioned Sri Lankan brand identity in the global market have greater opportunity in the Chinese market. For Small and Medium Enterprises (SMEs), participation at main trade fairs such as South Asia Kunming Expo, CIIE, Canton Fair, CISMEF is one of the strategies to entering to the Chinese market enabling them to understand the market dynamics and export readiness.

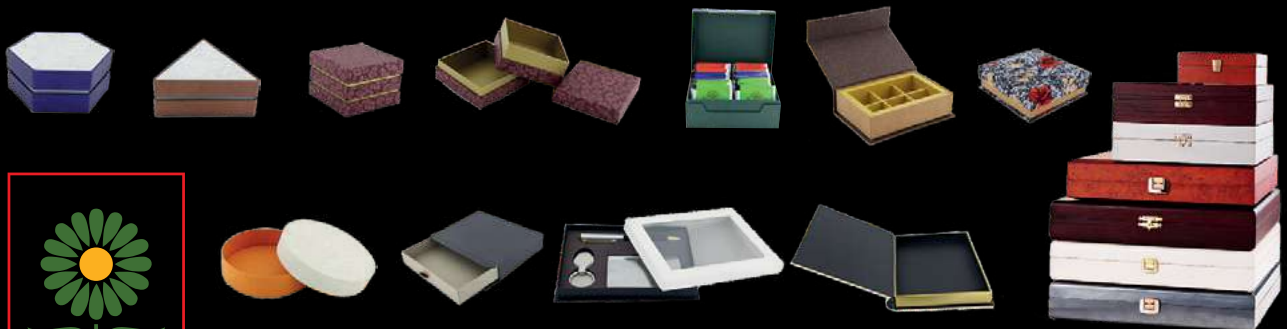

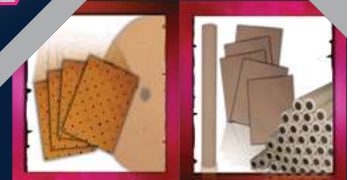
