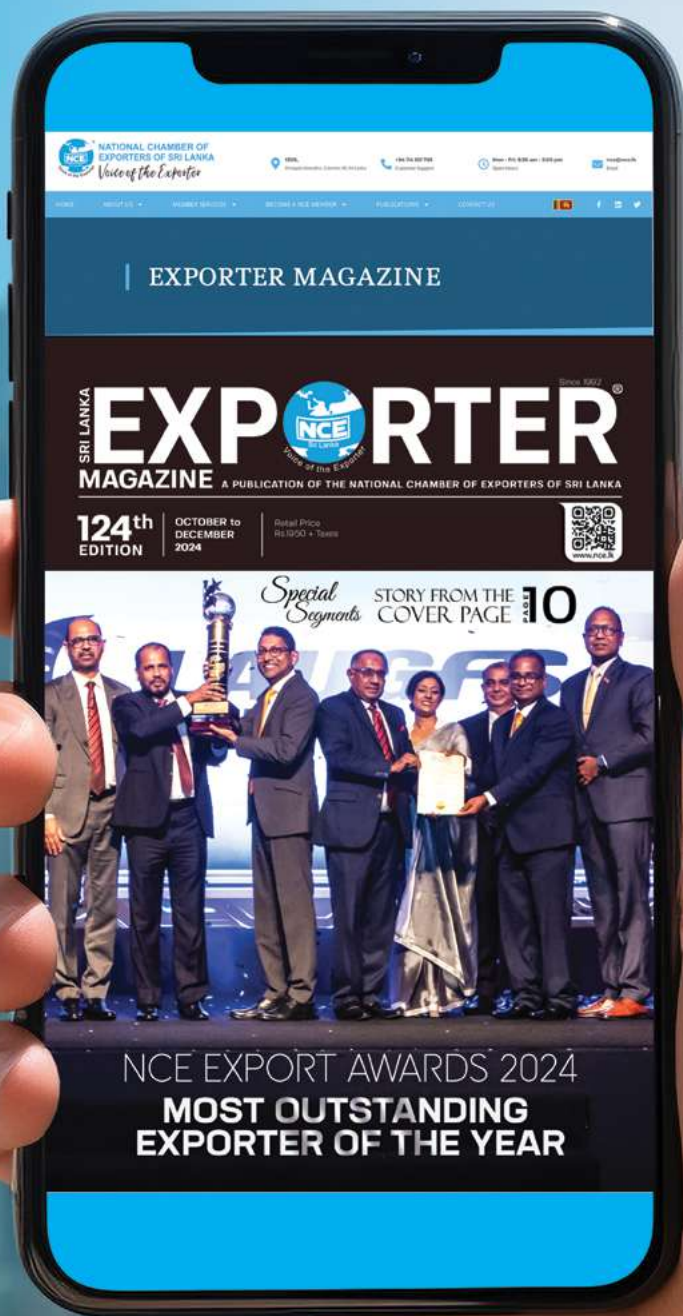

To maintain a competitive edge in the market, exporters must adhere to Fair and Ethical Trading Practices, safeguard the environment, and promote sustainable development.

Understanding the significance, the National Chamber of Exporters of Sri Lanka (NCE) issues a 'Certificate of Ethical Trading' to its Member Exporters who adhere to Ethical Trading Practices, Good Governance, and conformity to sound environmental and social practices based on the 08 Principles which are listed below.

PRINCIPLE 1

Trading Practices

Trades with considering for the social, economic and environmental well-being of the country and prevents them from being exploited for the profit of others. Also, adopts trading and operational policies that are acceptable to all Stakeholders.

PRINCIPLE 2

Payment of Statutory Wages

Pay wages and statutory commitments to all its employees according to National requirements

Child Labour and Forced Labour

FROM VISION TO ACTION

NCE PRESIDENT CHARTS THE FUTURE OF SRI LANKAN EXPORTS

AN EXCLUSIVE INTERVIEW WITH NEWLY ELECTED NCE PRESIDENT, MR. INDHRA KAUSHAL RAJAPAKSA

Q *Mr. Rajapaksa, congratulations on your election as the President of the NCE. Can you tell us about your journey with the Chamber so far?*

A: Thank you. It's a great honour to serve in this role. My journey with the NCE began in 2008 as a member. Since then, I've had the privilege of serving on the Council from 2014, taking on roles as an office bearer starting in 2018, and later serving as Vice President. Over these years, I've witnessed the Chamber evolve into a highly proactive, results-oriented institution. It has been both inspiring and rewarding to contribute to this transformation.

Q *What is your overarching vision for the export sector under your leadership?*

A: My vision is centered on strengthening Sri Lanka's export sector through collaborative partnerships, strategic advocacy, and diversification. Our national export target is USD 19 billion by 2025. It's ambitious but achievable if we harness the collective efforts of both public and private stakeholders. The key is to work smarter—cutting red tape, engaging with policymakers early, and addressing real-time challenges exporters face.

Q *Speaking of challenges, what are some of the critical issues you believe must be addressed immediately?*

A: There are several. Bureaucratic inefficiencies, trade barriers, and policy uncertainties continue to hold exporters back. One pressing concern is the removal of the SVAT scheme. If proper VAT refund mechanisms aren't in place, especially for SMEs, we risk cash flow disruptions. We at the NCE are actively lobbying for a smooth transition and urging policymakers to consult us before introducing any new trade-related policies.

Q *You've often spoken about the need to diversify Sri Lanka's export basket. Could you elaborate on that?*

A: Absolutely. Relying on a narrow set of industries makes our economy vulnerable. We must invest in emerging sectors like shipbuilding, marine offshore services, electronics, processed food, renewable energy, and vehicle accessories. These sectors not only promise sustainable growth and foreign exchange earnings but also offer greater integration into global value chains. With our strategic location in the Indian Ocean, Sri Lanka can be a regional hub for maritime and offshore industries.

Q *The Secretariat plays a central role in the Chamber's activities. What's your view on its current contributions?*

A: The Secretariat, led by our Secretary General Mr. Shiham Marikar, is doing an exceptional job. From organizing the prestigious NCE Export Awards to running capacity-building programs, they've significantly supported exporters. Another standout initiative is the Certificate of Ethical Trading (CET), which over 100 members have received since 2019. We're now working on securing accreditation for it through the Sri Lanka Accreditation Board, further enhancing its value.

Q *What are some of the key focus areas you plan to drive during your tenure?*

A: There are six major focus areas:

1. **Enhancing collaboration** – strengthening partnerships with government, private stakeholders, and international institutions.
2. **Expanding market access** – especially through partnerships with overseas trade chambers.
3. **Trade delegations in 2025** – to key regions like the Middle East, Scandinavia, the UK, and the Far East.

4. **Addressing workforce shortages** – by working with the Ministry of Labour to develop skilled training programs.
5. **Madrid Protocol implementation** – to boost competitiveness through better trademark protection.
6. **Single Window System** – advocating for a streamlined export process to reduce delays and bottlenecks.

Q *You mentioned working with Sri Lankan missions overseas. What role will they play moving forward?*

A: Our overseas missions are a key pillar of our strategy. With support from the relevant ministries, we're working closely with these missions to actively connect Sri Lankan exporters with international buyers and facilitate FDI. In the next few months, we'll roll out a dedicated platform to help our members engage more effectively with these missions and strengthen trade ties globally.

Q *Finally, what message would you like to share with the members of the NCE and the broader export community?*

A: My message is simple: **let's work together**. Achieving our goals requires the full cooperation of the Council, Management Committee, Secretariat, and every member. Your insights and contributions are vital. Together, we can shape forward-thinking policies, remove obstacles, and build a more resilient, competitive export sector. The NCE has a rich legacy, and with purpose and unity, we can take it—and Sri Lanka's exports—to new heights.

Q *Thank you, Mr. Rajapaksa, for sharing your thoughts and plans. We wish you every success in your tenure.*

A: Thank you. I look forward to working with all our stakeholders to realize our shared vision for an export-driven Sri Lanka.

On 13th February 2025, the NCE held a productive meeting with the Dhaka Chamber of Commerce & Industry (DCCI) in Bangladesh to explore potential collaborations. The meeting was facilitated by Ms. Srimali Jayarathna, Counsellor (Commercial) at the High Commission of Sri Lanka in Dhaka, paving the way for strengthened trade ties between the two countries.



Engagement with Birmingham Chamber of Commerce - GBCC

Continuing its efforts to deepen international business links, the NCE met with the Birmingham Chamber of Commerce (GBCC) on 31st January 2025. Building on the Memorandum of Understanding signed in 2023, the meeting focused on furthering the cooperative framework between the two chambers and exploring avenues for mutual benefit.



Webinar on Business Opportunities in Indonesia

In collaboration with the Embassy of Sri Lanka in Jakarta and the Indonesian Chamber of Commerce and Industry (KADIN), the NCE successfully conducted a webinar on 18th March 2025. Stakeholder Engagements & Strategic Dialogues

NCE AT THE FOREFRONT OF EXPORT ADVOCACY

Over the past quarter, the NCE has actively engaged with key ministries, government bodies, international institutions, and private sector stakeholders to further its mission of empowering Sri Lankan exporters. Here's a look back at our recent activities:

Strategic Engagements with the Hon. Minister of Industries



The NCE held two impactful meetings with the Hon. Minister of Industries—on **15th January** and **5th March 2025**—focusing on a range of initiatives aimed at strengthening Sri Lanka's export sector and industry policy environment. During these discussions, the NCE officially handed over its **policy recommendations** and held extensive dialogue on strategic plans to elevate the national export agenda. Key outcomes from these engagements include:

- **Sectoral Representation:** The Ministry pledged to formally include **NCE Council Members in Sector Advisory Committees**, providing a structured platform for addressing sector-specific challenges in policy development.
- **Expo 2026 Proposal:** The NCE proposed organizing a **Sri Lankan Expo in 2026**, aimed at promoting local products to global markets. Discussions on this initiative will continue throughout the year.
- **"Sri Lankan Brands" Pavilion at Osaka Expo 2025:** The NCE will lead the creation of a dedicated Sri Lankan Pavilion at this global event, showcasing the country's innovation and product excellence.
- **Digital Portals for Trade Facilitation:**
 1. One portal will enable **Sri Lankan trade officers in foreign missions** to submit regular updates on market initiatives and opportunities for exporters.
 2. Another portal will list **region-wise raw materials and**



goods, allowing exporters to identify local buy-back opportunities and improve supply chain transparency.

- **Policy Influence and Reforms:** The NCE will play a consultative role in shaping and responding to new policy matters initiated by the Ministry, ensuring exporters' voices are represented.
- **Streamlining Approvals:** Specific attention was given to the **boat-building sector**, with plans to simplify approval processes and minimize operational delays.
- **Support for Niche Industries:** The Ministry committed to supporting the **ornamental fish industry**, including the launch of a specialized online portal to increase visibility and streamline operations.
- **Website Modernization:** The Ministry's website is set for a comprehensive upgrade, transforming it into a centralized portal featuring detailed exporter, supplier, and stakeholder information.
- **Exporters' Development Council of Ministers:** A new **Management Committee** will be established to enhance governance and coordination in export development.

These meetings reaffirm the Ministry's and NCE's shared vision for a vibrant, resilient, and globally competitive export sector, with continued collaboration expected to drive impactful results for exporters across the island.



Meeting with SLECIC Chairman

On **21st January 2025**, the NCE team met with the Chairman and senior officials of the **Sri Lanka Export Credit Insurance Corporation (SLECIC)** to explore avenues for enhancing support services for exporters. The meeting focused on improving risk mitigation tools and export credit coverage.



Meeting with the Officials of CHEC Port City

Officials from CHEC Port City visited NCE on the 21st January 2025 to explore potential collaborations aimed at supporting Sri Lanka's export sector. Discussions focused on leveraging Port City's infrastructure to enhance market access, promoting investments, and co-hosting trade expos and networking events. Both parties also explored opportunities in sustainability, innovation, and policy advocacy to create a competitive, investor-friendly environment. The meeting concluded with a shared commitment to fostering economic growth and strengthening Sri Lanka's position in global trade.



Meeting with Ace Cargo (Pvt) Ltd to Enhance Export Efficiency

On 10th February 2025, NCE officials met with Mr. Nishan Jayawardena and his team from Ace Cargo to explore tailored logistics solutions that enhance efficiency for exporters. The partnership aims to support smoother, cost-effective export processes.



NCE Meeting with the Hon. Minister of Trade

On 11th February 2025, the NCE team met with the Hon. Minister of Trade, Commerce, Food Security & Co-operative Development to discuss key export-related matters. Highlights of the discussion included the appointment of Trade Officers in international markets, the Pakistan-Sri Lanka Free Trade Agreement (FTA), and Sri Lanka's accession to the Madrid Protocol.



Official Opening of the Local Geographical Indications (GI) Registry

Sri Lanka has officially launched the Local Geographical Indications (GI) Registry, established by the National Intellectual Property Office (NIPO) on 27th February 2025.

This landmark initiative marks a significant milestone in strengthening intellectual property rights and enhancing the value of Sri Lanka's unique products in both local and international markets.

The event was organized by NIPO, supported by the European Union and the United Nations Industrial Development Organization (UNIDO), held under the esteemed patronage of Hon. Mr. Wasantha Samarasinghe, Minister of Trade, Commerce, Food Security, and Co-operative Development.

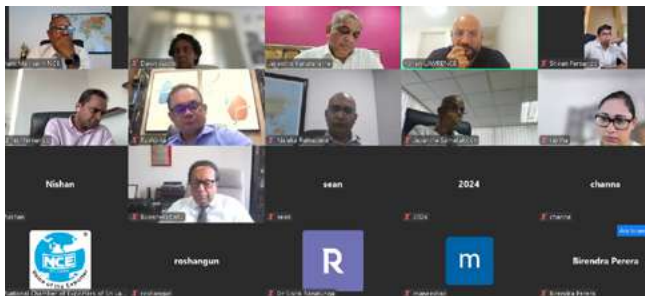

Pre-Validation of the Revised National Green Reporting System (NGRS)

On 4th March 2025, NCE joined stakeholders at Water's Edge for the pre-validation of the revised NGRS Guidelines, hosted by the Ministry of Environment. The session aimed to enhance the sustainability reporting framework in alignment with global standards, with NCE contributing its expertise and perspectives.

Joint Chamber discussion on Removal of SVAT



On 06th of March 2025, seventeen chambers and associations gathered for a Zoom session to discuss the ongoing SVAT matter. The session was led by the NCE. Concerns were raised regarding the SVAT removal in September 2025 and Inland Revenue Department's (IRD) ability to manage timely VAT refunds, particularly due to a lack of coordination with Customs, which could delay refunds for up to six months.

Additionally, there were discussion that corruption may resurface, similar to the period before the introduction of SVAT, when VAT

refunds were allegedly linked to bribery. To address the backlog of refunds, it was proposed that large-scale exporters be consulted to quantify the issue, with a comprehensive report submitted to authorities. Another major concern is that removing SVAT could create a significant cash flow burden on exporters, forcing them to borrow funds to manage negative cash flows. A study will be conducted to assess the additional costs exporters would incur if they had to finance working capital through borrowing. It was also clarified that the removal of SVAT is not an IMF condition, but rather a proposal from Sri Lankan authorities to tackle perceived revenue leakages.

Moving forward, two options were discussed during the meeting: advocating for the retention of SVAT while addressing its issues or working with the government on its removal by September 2025. If removal is necessary, it is crucial that the IRD develops a functional VAT refund system, and a pilot project involving all stakeholders be conducted for six months to ensure the system's effectiveness before full implementation. Associations were assigned tasks, such as gathering data on VAT refund backlogs and assessing the financial burden on exporters, with deadlines set for the end of March 2025. A meeting with the President and key stakeholders is also planned for early April 2025. The next steps are critical, and we urge all members to contribute to the efforts of gathering data and preparing a strong case to address exporters' concerns.



25th Exporters' Forum Hosted by EDB

The Sri Lanka Export Development Board (EDB) hosted the 25th Exporters' Forum at its headquarters on March 24th, 2025, providing a vital platform for exporters to voice their concerns and seek practical solutions to the challenges faced in the export sector. The National Chamber of Exporters (NCE) also actively participated in the forum, discussing various issues faced by member exporters and exploring possible solutions, including the abolishing of SVAT, digitalization of the custom procedure and issuing export-related documentations. The forum was graced by the Minister of Industry and Entrepreneurship Development, Hon. Sunil Handunnett; Hon. Chathuranga Abeysinghe, Deputy Minister of Industry and Entrepreneurship Development; Hon. Dr. Harshana Suriyapperuma, Deputy Minister of Finance and Planning; Hon. Susil Ranasinghe, Deputy Minister of Lands and Irrigation; and Hon. Eranga Udeshe Weeraratne, Deputy Minister of Digital Economy. Other participants included Mrs. Tilaka Jayasundara, Secretary of the Ministry of Industry and Entrepreneurship Development; Mr. Chaminda Pathiraja, Additional Secretary; Mr. Mangala Wijesinghe, Chairman/Chief Executive Officer; and other senior officials from relevant authorities.



National Single Window (NSW) Project: Towards Trade Facilitation

In March 2025, NCE took part in a stakeholder meeting led by the Deputy Minister of Finance to discuss the implementation of the **National Single Window Project**-a digital platform that promises to streamline trade documentation and clearance procedures for exporters and importers. NCE reiterated its full support for this transformative initiative.



Engagement with the World Bank – Export Competitiveness Focus

NCE met with **World Bank officials** to align on policy priorities related to export competitiveness and reform. We highlighted members' concerns, gained insight into ongoing government reforms, and discussed future collaboration for data-driven policy advocacy.

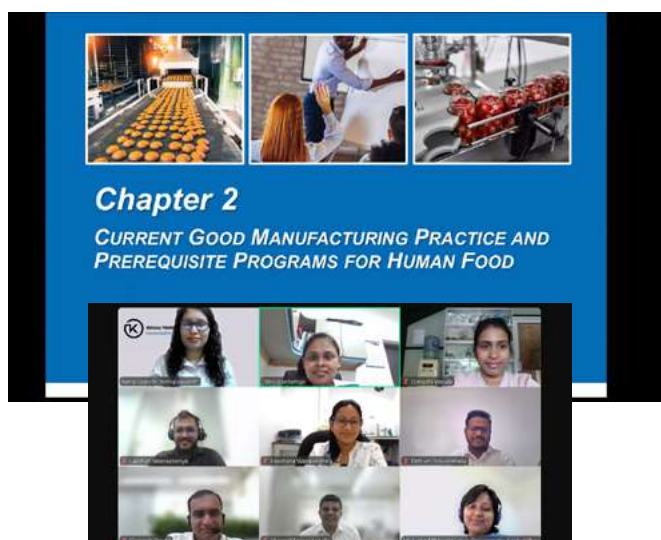


Seminar on Quality and Compliance requirements for Agri-Food Products

SVAT and the Future of VAT Refunds:

Is Sri Lanka Ready for the Transition?

As Sri Lanka prepares to overhaul its VAT refund framework, the decision to abolish the Simplified Value Added Tax (SVAT) system by October 1, 2025, has sparked growing concern among exporters. While the government aims to modernize tax administration and align with international best practices, the readiness of the Inland Revenue Department (IRD) to implement a reliable alternative remains in question.

SVAT: A Solution That Worked

Introduced in 2011, SVAT was designed to address three persistent challenges in Sri Lanka's VAT system:

- **Cash flow constraints** for exporters due to delayed refunds.
- **Administrative inefficiencies** within the IRD.
- **Rampant VAT refund fraud**, which had previously cost the state millions.

SVAT replaced cash refunds with a credit voucher system, allowing eligible businesses to offset VAT liabilities without waiting for the refund from the Inland Revenue Department. This cashless mechanism significantly reduced opportunities for fraud and corruption while improving transparency.

The Push for Reform—and the Risks

In line with recommendations from the International Monetary Fund (IMF), the Government has committed to transitioning to a risk-based VAT refund model. As per the VAT Amendment Act No 04 of 2025, certified by the speaker on 11th April 2025, the excess input tax of

- eligible exporters or
- registered persons whose value of supplies exceeds 50% of their total supplies to Strategic Development Projects or Specified Projects for the taxable period or
- projects approved under section 22(7) of the VAT Act,

will be entitled to VAT refund not later than 45 days from the due date of the VAT return submission and subject to the submission of a proper VAT return.

An “**eligible exporter**” means a registered person whose value of zero-rated supplies, during the preceding

calendar year, was greater than 50% of the total value of supplies made by that person during the same period.

The Inland Revenue Officers are currently focused on a pilot project, with the goal of issuing refunds within 45 days of the end of the taxable period, subject to conditions outlined by the Commissioner General of Inland Revenue.

However, the Inland Revenue Department's track record raises doubts about the feasibility of this timeline. Refund backlogs dating back over two decades remain unresolved, and recent administrative actions have only deepened taxpayer skepticism.

On December 12, 2024, the IRD issued a notice requiring taxpayers with pending VAT refund claims for periods before December 31, 2015, to submit a written request—signed by the Managing Director—by December 31, 2024. The notice warned that claims submitted after this deadline would not be considered.

This directive is legally questionable. It contradicts the VAT Act, which entitles taxpayers to refunds duly claimed in their returns. This action would have impacted the taxpayer's confidence.

Exporters Face Mounting Pressure

The 2025 Budget targets a record USD 19 billion in export earnings. Yet, the tax policy landscape appears increasingly misaligned with this ambition. The corporate income tax rate for goods exports stands at 30%, while service exports are now taxed at 15% following the removal of the income tax exemptions. The removal of SVAT adds another layer of financial and administrative pressure.

Exporters, particularly small and medium-sized enterprises (SMEs) are increasingly concerned about the potential return of refund delays. Without SVAT, they will

be forced to rely on timely cash refunds from the IRD to manage working capital. Delays could lead to greater reliance on borrowing and higher interest expenses.

A Call for Strategic Patience

With less than six months remaining before SVAT is abolished, one must ask whether, rather than rushing to dismantle SVAT, the Government should consider a phased approach:

- **Retain SVAT for identified sectors** while piloting the new system.
- **Strengthen SVAT's governance** through enhanced audits and digital integration.
- **Establish a robust mechanism to clear outstanding VAT refunds**, which would enhance taxpayer confidence.
- **Roll out targeted communication on the risk-based refund mechanism and the importance of compliance**

Sri Lanka has struggled for over 25 years to implement a robust, corruption-free tax refund system. SVAT, while not perfect, has been a rare success story. Before discarding it, policymakers must ensure that its replacement is technically sound, digitally driven, and does not disrupt business.

The SVAT mechanism has provided exporters with predictability, transparency, and efficiency. Until the new refund system is fully operational and proven, maintaining SVAT is not just prudent—it's essential for economic stability and export-led growth.

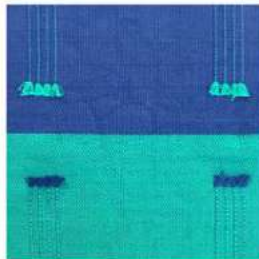

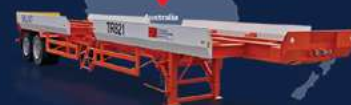
