## CHAMBER ACTIVITIES

### Advancing R&D Commercialization in Sri Lanka



On June 3, 2025, officials from the National Chamber of Exporters of Sri Lanka (NCE) held a strategic meeting with the Director General and team of the National Initiative for Research and Development Commercialization (NIRDC), a government body committed to transforming research outputs into commercially viable products. The two organizations explored multiple avenues of collaboration, including identifying near-completed research with strong market potential, bridging funding gaps that delay commercialization, and building a dynamic platform to connect investors with ready-to-launch innovations. The NCE will also play a key role in linking its members—especially R&D-driven companies—with NIRDC to co-create value through innovation, while simultaneously promoting knowledge-sharing across the export sector.



# Building Global Visibility through the WIM Awards

NCE Officials engaged with the team at Women in Management (WIM) on June 3, 2025, to discuss collaboration around the upcoming WIM UK Top 50 Professional and Career Women Awards 2025. This prestigious international event, scheduled for November, recognizes outstanding female leaders from around the world and attracts a high-profile audience of professionals and investors.

The discussion centered on creating opportunities for NCE member exporters to showcase their brands at the awards ceremony and affiliated events. Plans include integrating

export promotional activities into the WIM forums, thereby enhancing international exposure and building networks with global stakeholders. A formal partnership between WIM and NCE is currently being finalized.



## Expanding Market Access in Italy



The NCE, in collaboration with the Consulate General of Sri Lanka in Milan and the Italian Association of Foreign Trade (AICE), hosted a focused webinar for over 30 Sri Lankan exporters on the June 3, 2025. The session explored market entry strategies and growth opportunities for Sri Lankan products—particularly coconut-based goods, seafood, rubber, and rubber-based products—in the Italian market.

# Empowering Regional Exporters through Innovation and Enterprise



On June 5, 2025, the NCE officials held a productive meeting with the Chairman of the National Enterprise Development Authority (NEDA) to explore collaborative efforts aimed at nurturing entrepreneurship, stimulating grassroots innovation, and enhancing regional export capabilities.

A key highlight of the discussion was the proposed Export House in the Northern Province, which would serve as a centralized platform for aggregating local products and offering aspiring exporters the training, networks, and capacity-building tools needed to reach international markets. The collaboration also envisions strong ties with academic institutions to support research and entrepreneurship initiatives linked to the export economy.

## Insights into Financial Planning and Risk Management



The NCE hosted the second technical seminar in its knowledge-sharing series at the NCE Conference Hall on the June 5, 2025. The session, attended by over 20 participants, focused on Financial Planning and Risk Management—two critical areas for exporters in an increasingly volatile global market.

The event was elevated by the presence of the Sri Lankan High Commissioner-designate to South Africa, and featured a keynote address by renowned geopolitical commentator Imran Furkan, who spoke on emerging global trade trends, the impact of Trump-era tariffs, and the importance of adaptive export strategies.



## Strengthening Trade Ties with the United Kingdom



On June 13, 2025, the NCE Officials met with the British High Commissioner to Sri Lanka to present the latest edition of the Sri Lanka Export Brands Magazine—a flagship publication that showcases the country's leading exporters to a global audience.

Discussions included plans for a Sri Lankan Exporters Delegation to the UK in late 2025 and collaborations with UK-based donor agencies to advance ethical and

sustainable trade. The Certificate of Ethical Trading (CET) was also introduced, with prospects for recognition by British certification authorities.

## Advancing Bilateral Trade with India

NCE Officials participated in a High Tea meeting at the invitation of the Indian High Commission on the June 13, 2025, where discussions were held with the First Secretary to address key issues impacting Sri Lankan exporters to India. Topics included strategies to overcome non-tariff barriers (NTBs), boosting trade relations with Indian chambers, and



developing training programs for exporters. This meeting set the stage for a follow-up session with the Indian High Commissioner.

## Opening Doors to Latin America via Cuba



On June 17, 2025, the NCE Officials met with H.E. the Ambassador of Cuba to Sri Lanka to explore Sri Lanka's participation at the Havana International Fair (FIHAV 2025)—one of Latin America's premier trade exhibitions.

The Ambassador emphasized Cuba's potential as a gateway to wider Latin American markets. As a next step, NCE will organize virtual B2B meetings in collaboration with the Cuban Chamber of Commerce, connecting exporters with Cuban businesses across multiple sectors.

## Regional Synergies with Bangladesh



NCE hosted a high-level business delegation from Bangladesh on the June 17, 2025,, organized by the Dhaka Chamber of Commerce & Industry (DCCI). The B2B forum brought together 30 Bangladeshi business leaders and 35 Sri Lankan exporters to explore joint trade and investment opportunities. The NCE thanks the Sri Lankan High Commission in Dhaka for facilitating this valuable bilateral initiative.



## Enhancing Export Prospects with Türkiye



On June 18, 2025, the NCE welcomed H.E. the Ambassador of Türkiye for an in-depth discussion on growing trade ties between the two nations. Key product categories discussed included tea, tiles, boats, rubber products, solid tyres, and rice.

The Ambassador expressed strong support for connecting NCE with Turkish industry bodies to foster mutually beneficial partnerships.

## NCE Strengthens Global Business Links through Partnership with GFSLBC



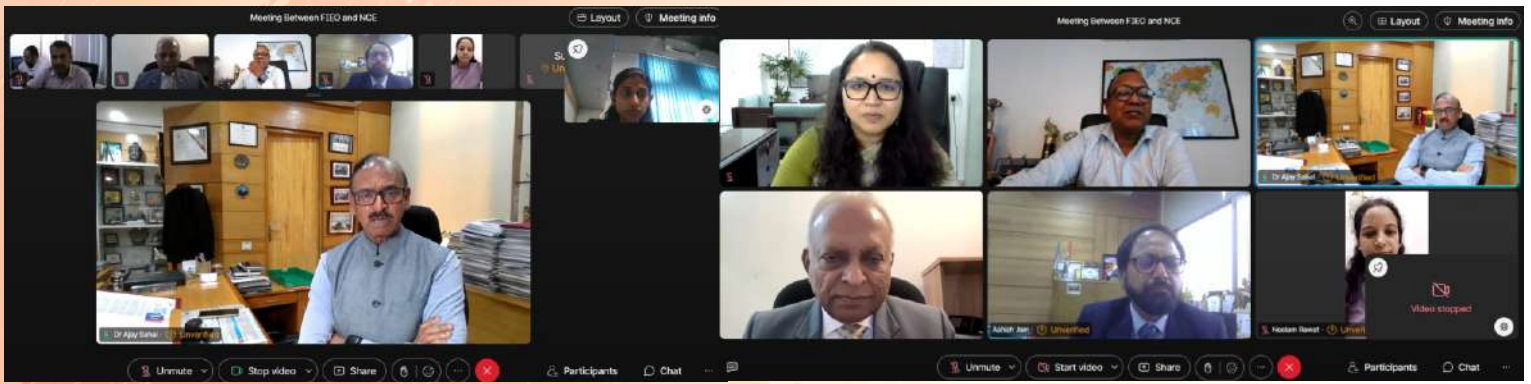

## Trade Related Information

### External Sector Performance – April 2025

Sri Lanka's merchandise trade deficit widened in April 2025 compared to both April 2024 and March 2025. The expansion in the trade gap was primarily driven by a significant increase in merchandise imports, which grew by 17.5% year-on-year. A key contributor to this surge was the importation of motor vehicles, totaling USD 134 million.

In contrast, merchandise exports registered a moderate growth of 10.4% year-on-year, which was not sufficient to offset the faster pace of import growth.
