Meeting between NCE and Greater Stouffville Chamber to discuss a potential collaboration





Strengthening Regional Collaboration for Export Growth



The discussions emphasized the promotion of regional outreach programme aimed at empowering aspiring exporters, along with advancing the Certificate of Ethical Trading (CET) to encourage responsible and sustainable business practices. These initiatives are designed to enhance exporters' credibility and competitiveness in international markets.

The Colombo Plan expressed its interest in partnering with the NCE, marking an important step toward expanding regional support for Sri Lanka's export community and reinforcing the nation's reputation as a leader in ethical and sustainable trade.

NCE Conducts Award Application Briefing Sessions Ahead of the Annual Export Awards 2025


NCE Holds Monthly Management and Council Meetings - August 2025

Preventive Controls Qualified Individual (PCQI) Training Programme

This program plays a crucial role in ensuring the highest standard of safety and quality in the sector. The course took place on from 26th to 29th August 2025, for a total of 22 hours. Using the ease and accessibility of e-learning, the training was delivered via Zoom, allowing participants to participate remotely. There were 08 participants present at this time.

NCE Strengthens Trade Engagement with Pakistan



On 25th August 2025, the National Chamber of Exporters of Sri Lanka (NCE) recently held a productive meeting with Mr. Sanjeewa Pattiwella, Designated Consul General to Pakistan, and Ms. Mahwash, Trade Secretary at the Pakistan High Commission, to explore opportunities for enhancing bilateral trade.



The discussions reviewed the potential of the Sri Lanka-Pakistan Free Trade Agreement (SLPFTA), which remains underutilized but offers promising avenues for exporters. Efforts are already underway to strengthen trade data analysis, identify new sectoral opportunities, and prepare for a Business Delegation to Karachi in November 2025, in collaboration with the Sri Lankan Consulate General, the Pakistan Embassy, and a leading chamber in Karachi. These initiatives reflect NCE's continued commitment to unlocking new opportunities for Sri Lankan exporters while reinforcing trade partnerships with Pakistan.

NCE Hosts Producer-Exporter Linkage Event in Matara



On 28th August 2025, the National Chamber of Exporters of Sri Lanka (NCE), in collaboration with the Agriculture Department and Training Unit (ADTU) of the Ministry of Agriculture, successfully organized a Producer–Exporter Linkage Event in Matara.
