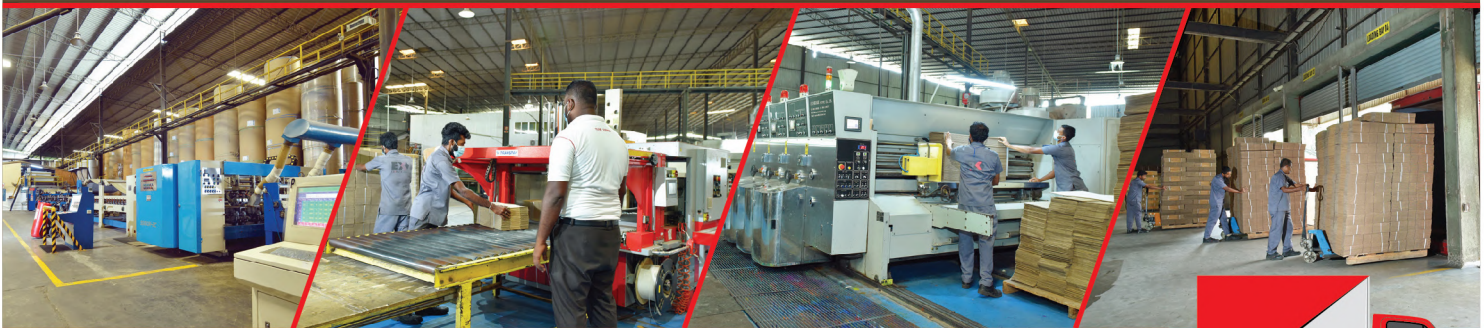

Understanding the significance, the National Chamber of Exporters of Sri Lanka (NCE) issues a 'Certificate of Ethical Trading' to its Member Exporters who adhere to Ethical Trading Practices, Good Governance, and conformity to sound environmental and social practices based on the 08 Principles which are listed below.

PRINCIPLE 1

Trading Practices

Trades with considering for the social, economic and environmental well-being of the country and prevents them from being exploited for the profit of others. Also, adopts trading and operational policies that are acceptable to all Stakeholders.

PRINCIPLE 2

Payment of Statutory Wages

Pay wages and statutory commitments to all its employees according to National requirements

Child Labour and Forced Labour

A LEGACY CARVED IN STONE

SRI LANKA'S GEMS AND JEWELLERY SECTOR: A TIMELESS LEGACY WITH MODERN CHALLENGES

Few industries can rival the historical and cultural depth of Sri Lanka's gems and jewellery sector. For over 2,500 years, the island has been recognized globally as a rich source of exceptional gemstones, earning the name "*Ratna-Dweepa*", or "Island of Gems", in ancient Sanskrit texts.

From ancient traders and monarchs to modern collectors and jewellers, Sri Lankan gems—especially its world-renowned Ceylon sapphires—have captured the admiration of generations. The country's central gem-bearing regions such as Ratnapura, Elahera, and Bibile remain vibrant centers of artisanal and small-scale mining to this day.

These rich deposits have yielded some of the world's most famous stones, including the **Queen of Asia**, a 310kg natural blue sapphire valued at over USD 150 million, and the **Serendipity**

Sapphire, a 510kg star sapphire cluster discovered in Ratnapura.

The Modern Industry: Between Legacy and Opportunity

Today, Sri Lanka's gems and jewellery sector remains a pillar of the economy. With activities spanning mining, cutting, polishing, jewellery manufacturing, and global export, the industry employs over **600,000** people across the formal and informal sectors.

Sri Lanka is globally ranked among the top five gem-bearing nations and stands as the **9th largest exporter of precious stones**. It is also recognized for adhering to ethical mining and trading practices, which has elevated its reputation in competitive international markets.

Export Performance: A Mixed Trajectory (2018–2025)

Despite its rich natural advantage, the industry's export performance has shown volatility over recent years, often shaped by global market conditions and domestic policy decisions.

Export Revenue Overview (Gems, Jewellery & Diamonds)

Year	Export Revenue (USD million)
2018–2021 (Avg.)	~298
2022	450
2023	315
2024	360 (estimated)
2025 (Projected)	500 (USD 312m by July)

- ♦ **2022** was a standout year, with revenues reaching **USD 450 million**, significantly above the five-year average.
- ♦ In **2023**, the industry saw a decline to **USD 315 million**, although still reflecting a 34% YoY increase compared to 2022 in specific quarters.



- ♦ By **2024**, export figures stabilized at an estimated **USD 360 million**, but fell short of expectations due to newly introduced taxes.
- ♦ **2025** has shown signs of recovery, with **USD 312 million** already earned by July, setting the pace toward a **USD 500 million** year-end target.

Challenges: A Heavy Tax Burden

One of the most pressing challenges currently facing the sector is **taxation policy**. In 2023–2024, the imposition of:

- ♦ **18% VAT** on local gem sales and tourist transactions, and
- ♦ A **45.14% tax on gold imports**

...has significantly reduced competitiveness, dampened domestic demand, and discouraged exports. According to several industry reports, these tax burdens have not only reduced profitability but also prompted some exporters and traders to consider

relocating operations to more tax-friendly markets such as **Dubai, Thailand, India, and Hong Kong**, where VAT and import duties are minimal or zero.

The Road Ahead: Reform and Revitalization

Despite the setbacks, the industry holds immense promise. The National Gem and Jewellery Authority (NGJA) has introduced strategies aimed at positioning the sector to reach a **USD 2 billion export target by 2030**. This includes:

- ♦ Promoting **international exhibitions** and trade fairs,
- ♦ Streamlining the export licensing process,
- ♦ Introducing **incentives for value-added exports**, and
- ♦ Collaborating with international certification bodies to maintain transparency and quality.

Furthermore, greater investment in **modern lapidary technology, design innovation**, and **sustainable mining practices** could elevate Sri Lanka's standing in the global gems and jewellery market even further.

Sri Lanka's gems and jewellery sector stands at a pivotal moment. Grounded in an illustrious past and supported by natural bounty, it is uniquely positioned to be a global leader in ethical and high-value gemstone exports. However, to fully reveal its potential, a collaborative effort between government, industry stakeholders, and the export community is needed to address pressing policy barriers and to foster a globally competitive business environment.

The Role of Policy and Regulations of the National Gem and Jewellery Authority in Strengthening Sri Lanka's Global Competitiveness in the Gem and Jewellery Sector

The **National Gem and Jewellery Authority (NGJA)** is the sole government regulatory body entrusted with the regulation, promotion, and development of Sri Lanka's gem and jewellery industry. Its overarching responsibility is to ensure the sustainability and integrity of the industry by overseeing the entire value chain—from mining to export.

Under its statutory mandate, the Authority issues licenses for all key stakeholders in the industry, including **gem miners, lapidary operators, jewellery manufacturers, traders, and exporters**. The NGJA also plays a

pivotal role in ensuring environmentally responsible mining practices. Through initiatives aimed at **environmental rehabilitation** and the promotion of **ethical mining**, the Authority prioritizes sustainability and recognizes miners who adhere to responsible standards.

The value addition segment—encompassing **gem cutting, processing, heat treatment**, and other enhancement techniques—plays a critical role in elevating Sri Lanka's global positioning. As the regulatory body, the NGJA ensures that **treatment processes meet international standards** and that any



enhancements made to gemstones are **disclosed transparently at the point of sale**, thereby protecting consumer rights and market integrity.

Jewellery, one of Sri Lanka's oldest and most culturally significant crafts, requires stringent quality assurance to maintain buyer confidence. To this end, the **Sri Lanka Assay Office**, operating under the NGJA, tests and certifies the **purity of precious metals**, ensuring that jewellery sold in the local and international markets meets the highest quality standards. Likewise, the **Gem Testing and Certification Laboratory**, equipped with modern instruments and internationally accredited gemmologists, issues credible certifications that uphold consumer trust and deter unethical trading practices.

All gem and jewellery exports are facilitated through the **Gem and Jewellery Exports Department** of the NGJA, which operates as a **"One-Stop Centre"**. This centralized facility streamlines the export process, allowing exporters to complete necessary procedures within a short time. A **dedicated help desk** supports new exporters, and the Authority conducts **regular awareness programs** to build capacity and encourage greater participation in global trade.

Under the leadership of **Hon. Sunil Handunneththi**, Minister of Industries and Entrepreneurship Development, the NGJA has initiated the **digital transformation** of the licensing and export facilitation systems. The new **digital platform**, expected to launch in **January 2026**, will improve efficiency, transparency, and accessibility for industry stakeholders.

The NGJA has also played a key advocacy role in **addressing regulatory and fiscal challenges** faced by the industry. One major success was in **resolving the VAT issue on imported gemstones**, which previously hindered the value addition segment. After extensive engagement with the Treasury and His Excellency the President, the NGJA secured approval for a **policy amendment** to facilitate imports of gem materials essential for lapidary and jewellery manufacturing.

Another significant milestone was the effort to **introduce a VAT refund mechanism for jewellery purchased by foreign tourists**, addressing a long-standing barrier to retail growth in the tourism sector. Through sustained negotiations with the **Department of Inland Revenue**, the NGJA helped implement an 18% VAT refund policy to stimulate high-value tourist purchases.

The NGJA continues to function as a **facilitator and advocate**, serving the **environment, industry, and consumers** alike. It works collaboratively with industry associations and government agencies to enhance Sri Lanka's international profile. Since its inception, the NGJA has co-organized **FACETS Sri Lanka** with the **Sri Lanka Gem and Jewellery Association**, and supports the **Gem Sri Lanka** exhibition in **Beruwala**, in cooperation with the Ministry of Foreign Affairs and the Sri Lanka Tourism Promotion Bureau.

Furthermore, to establish **Ratnapura** as the **primary sourcing city for gemstones**, the Authority organizes the **Gem City Ratnapura – International Gem and Jewellery Show**. This event is promoted globally with the support of the Ministry of Industry and Entrepreneurship Development, Sri Lanka Export Development Board, Ministry of Foreign Affairs, Sri Lanka Tourism Promotion Bureau, and the Department of Commerce.

With strategic direction from **Hon. Minister Sunil Handunneththi**, the NGJA continues to make **significant progress in policy reform and regulatory development**, while simultaneously **strengthening Sri Lanka's gem and jewellery industry** through global promotion, responsible governance, and sustainable development initiatives.

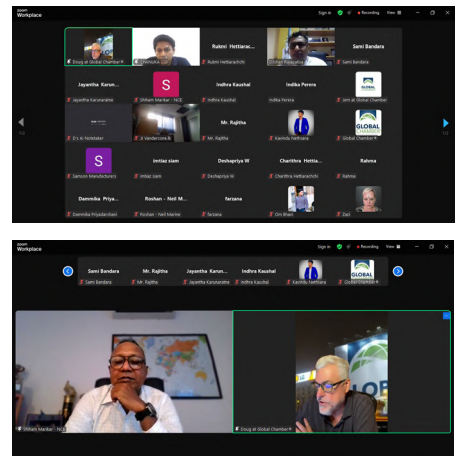
Showcasing Sri Lanka's Export Readiness to the United States

- **High Tea at the Indian High Commission:** NCE

officials met with senior Indian diplomats to address export challenges and discuss training and chamber-level collaborations.

These efforts collectively reinforce the NCE's commitment to deepening trade synergies with India and providing Sri Lankan exporters with strategic access to one of the world's fastest-growing markets.



Strengthening Trade Relations with Türkiye

Türkiye continues to emerge as a key market of interest for Sri Lankan exporters. The NCE engaged in two high-level initiatives:

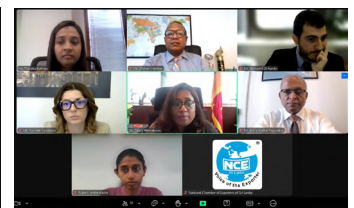

Over 30 Sri Lankan exporters participated, with an emphasis on coconut-based products, seafood, and rubber goods. This follows the MoU signed with AICE in 2024, advancing plans for outbound trade missions and long-term partnerships.



Building Latin American Trade Bridges via Cuba

In a strategic move to penetrate the Latin American market, the NCE engaged with H.E. the **Ambassador of Cuba to Sri Lanka** on 17th June to discuss Sri Lanka's potential participation in **FIHAV 2025**, one of the region's premier trade fairs.

Plans are underway to conduct **virtual B2B meetings** with the **Cuban Chamber of Commerce**, offering Sri Lankan exporters the opportunity to connect with businesses across diverse sectors in Cuba and beyond.



Fostering Regional Trade with Bangladesh

On 17th June, the NCE hosted a high-profile **business delegation from Bangladesh**, organized by the **Dhaka Chamber of Commerce & Industry (DCCI)**. The B2B forum welcomed 30 Bangladeshi business leaders and 35 Sri Lankan exporters, creating a fertile platform for joint trade and investment initiatives.

This bilateral event was made possible with support from the **Sri Lankan High Commission in Dhaka**, and exemplifies the NCE's dedication to expanding intra-regional trade in South Asia.



Promoting Investment Partnerships with Belgium

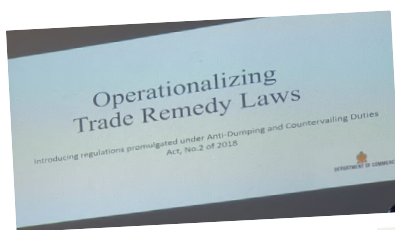

On May 19, 2025, the Ministry of Trade organized a vital stakeholder consultation to raise awareness on the implementation of the Anti-Dumping and Countervailing Duties Act No. 02 of 2018, which came into effect on March 27, 2025. This session introduced the newly established Trade Remedy Unit within the Department of Commerce, responsible for enforcing Sri Lanka's trade remedy laws and ensuring compliance with international trade standards. The National Chamber of Exporters (NCE) actively participated in this consultation, providing valuable insights to its members about the implications of anti-dumping investigations. By staying engaged in such regulatory developments, NCE ensures exporters are well-informed and prepared to navigate challenges that could affect their competitiveness in global markets.



Strategic Collaboration to Boost Regional Export Capacity Across Sri Lanka

In an effort to promote inclusive economic growth, the NCE held a strategic meeting on May 26, 2025, with key representatives from the Ministry of Finance's External Resource Department and the United Nations Development Programme (UNDP). The focus of this collaboration is to empower regional producers and aspiring exporters through targeted training and capacity-building initiatives. By equipping these entrepreneurs with the necessary skills and resources, the initiative aims to integrate them into the formal export value chain, thereby unlocking the untapped export potential across Sri Lanka's diverse regions. NCE Engages with JICA to Strengthen SME Exporters

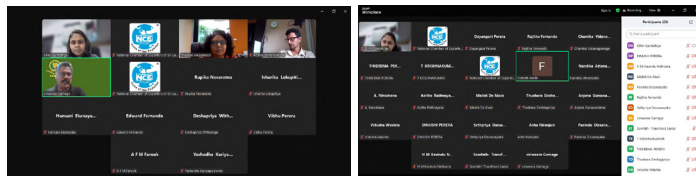
NCE Strengthens Global Business Links through Partnership with GFSLBC

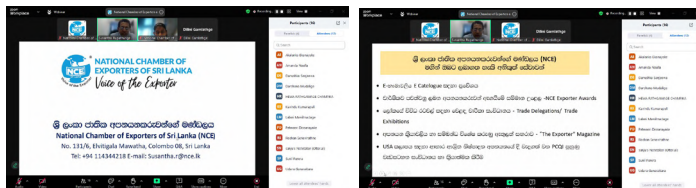
Strengthening Sectoral Engagement through Virtual Meetings

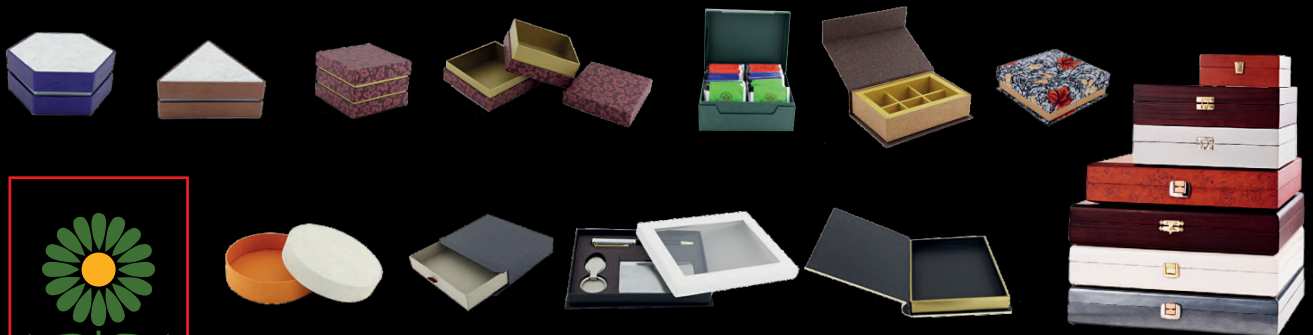



Sri Lanka's Export Pulse: January–May 2025

Sri Lanka's export sector has navigated the first five months of 2025 with resilience and pockets of exciting growth. Total export earnings hovered around the **USD 1 billion** mark each month, peaking in **March** at an impressive **USD 1.158 billion**, before easing to **USD 925 million** in April. The figures reveal a dynamic landscape—steady leaders, volatile niche players, and emerging growth stories.

The **Apparel & Textile** industry (S.10) remains the undisputed powerhouse. Over January–May, it amassed **USD 2.137 billion**, more than triple the earnings of its nearest rival. Notably, it topped the charts every single month, reaching its highest in March with nearly **USD 496 million** in shipments.

Following apparel, several sectors continue to underpin Sri Lanka's export strength:

- **Tea (S.01)** – USD 610 million total; steady, with March marking the high point.
- **Coconut & Coconut-based Products (S.03)** – USD 428 million; consistent growth trajectory.

- **Rubber & Rubber-based Products (S.02)** – USD 386 million; moderate performance despite April's dip.
- **Engineering Products (S.19)** – USD 257 million; strong month-on-month slope and May peak.

Growth Hotspots

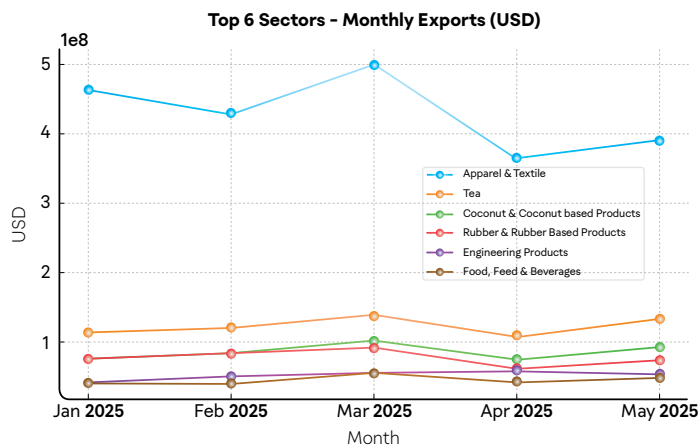
While absolute values are smaller, certain sectors are outpacing the rest in growth rate:

- **Miscellaneous Products (S.95)** – +5,628% from January to May, driven by irregular large orders.
- **Other Export Crops (S.07)** – +211% surge, with May tripling January's value.
- **Leather Products (S.13)** – +130% growth; May figures more than doubled January's.
- **Non-metallic Mineral Products (S.17)** – +24% growth, steady upward slope.
- **Footwear and Parts (S.20)** – +24% growth; small but promising base.
- **Coconut & Coconut-based Products (S.03)** – +23% growth; already a top-three sector.

Volatile Performers

Some categories demonstrate sharp fluctuations, suggesting susceptibility to global price swings or irregular demand:

- **Diamonds, Gems & Jewellery (S.09)** plunged from USD 42 million in January to USD 19 million in March, rebounding to USD 31 million in April.
- **Fish & Fisheries Products (S.08)** more than doubled from March to April before falling back in May.
- **Chemicals & Plastic Products (S.16)** spiked in April, doubling their typical monthly value.

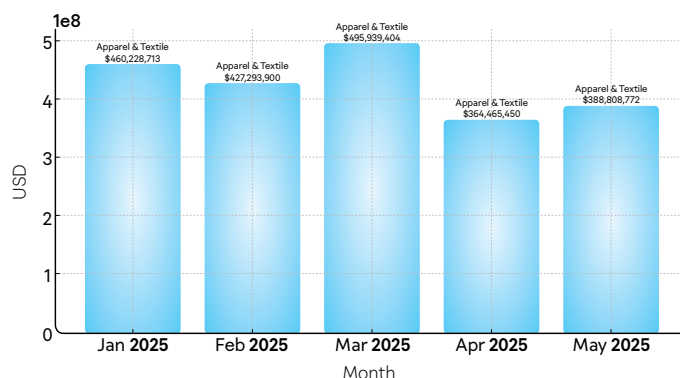

March's performance was boosted by peak apparel sales and strong tea exports, while April's dip reflected contractions in apparel, tea, and gems.

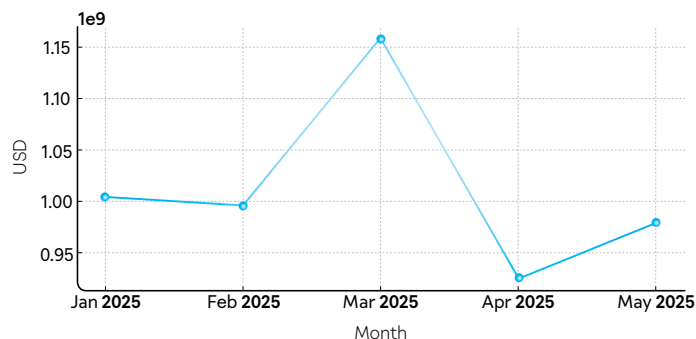
Sri Lanka's export structure in early 2025 remains heavily weighted toward apparel, yet the data points to promising diversification:

An overview of Sri Lanka-Indonesia Relations

by Embassy of Sri Lanka in Jakarta



The Republic of Indonesia is among the first countries to establish diplomatic relations with Sri Lanka soon after its independence. While initial contact began in 1950, formal diplomatic relations were established at the mission level on 6 August 1952. The close ties between the two nations were further symbolized by the participation of the Prime Minister of Sri Lanka in the historic Asian-African Conference held in Bandung, Indonesia, in 1955.

Both Sri Lanka and Indonesia share a colonial history under the Portuguese and Dutch, whose influence remains evident in aspects of religion, legal systems, and culture. Sri Lanka continues to have a Malay community approximately 0.3% of the population that settled during the colonial period and has contributed significantly to Sri Lanka's pluralistic society. Historical linkages between the two countries are further reflected in linguistic similarities, with Portuguese, Dutch, and Sanskrit loanwords present in both Sinhala and Bahasa Indonesia (e.g., *almari*, *meja*, *mantri*, *janela*, *dirghayu*, etc.). Popular dishes such as *nasi goreng*, *pittu*, and *dodol* are enjoyed in both countries, symbolizing centuries of cultural exchange.

Indonesia was also a significant Mahāyāna Buddhist center in Southeast Asia during the Sriwijaya Kingdom (7th–13th century AD). The Borobudur Temple, a UNESCO World Heritage Site and the largest Buddhist monument in the world, stands as a testament to this shared religious and cultural heritage.

In terms of trade, Indonesia was Sri

Lanka's 39th largest export destination in 2022. Sri Lanka's exports include apparel, rubber products, paper products, and more. Meanwhile, Indonesia was Sri Lanka's 10th largest import supplier in 2022, notably providing coal and fertilizer. Several Sri Lankan companies have invested in Indonesia across sectors such as apparel, logistics, microfinance, chemicals, and activated carbon, with total investments amounting to around USD 1 billion.

In 2024, approximately 7,000 Sri Lankans visited Indonesia, while about 15,000 Indonesians traveled to Sri Lanka for tourism, business, education, and other purposes. Direct air connectivity via SriLankan Airlines and visa-free access for Indonesian travelers have made Sri Lanka a popular destination, particularly among Indonesian Buddhist pilgrims.

With a growing middle class, Indonesia commands a luxury jewelry market worth approximately USD 250 million. Although the country is a renowned global supplier of gemstones and gold, Sri Lanka continues to attract Indonesian buyers due to the uniqueness of its gemstones and diamonds. Indonesian visitors frequently attend gem and jewelry exhibitions in Sri Lanka, such as FACETS.

As the largest economy in Southeast Asia and the fourth most populous country in the world, Indonesia aims to become a developed nation by 2045. It recently became the 11th member of BRICS and is actively pursuing membership in the OECD, reflecting its growing global influence. Since banning the export of

raw critical minerals such as nickel in 2020, Indonesia has sought to become a major player in the global electric vehicle (EV) battery supply chain. Southeast Asia's largest EV battery project, in partnership with China's Contemporary Amperex Technology Co. Limited (CATL), commenced operations in June 2025.

Sri Lanka and Indonesia continue to support each other's candidacies in multilateral and regional forums, including Sri Lanka's accession to the ASEAN Regional Forum in 2007. Both countries have signed numerous Memoranda of Understanding (MoUs) to strengthen cooperation in socio-economic development, culture and education, political dialogue, defence and security, among other areas. Negotiations are expected to resume soon on a Preferential Trade Agreement (PTA) between the two countries, which would further deepen bilateral economic ties.

In October 2024, a MoU was signed between the National Chamber of Exporters (NCE) of Sri Lanka and the Indonesian Chamber of Commerce and Industry (KADIN), leading to a series of business matching among interested companies as part of its implementation.

Over the past 73 years, Sri Lanka and Indonesia have fostered a relationship grounded in shared history, cultural bonds, mutual respect, and a strong commitment to regional cooperation. There remains immense potential to elevate this partnership, particularly in the areas of trade, investment, and maritime collaboration.
